Brady, who did not graduate in 1976 when he left GSC to start his career in the insurance industry, learned about Glenville State College's Regents BA Program when he was back on campus for the 20 year anniversary of the 1973 National Runner-up

Dr. Pellett also spoke about plans to develop unique program offerings and doing so in new markets and through a variety of instructional formats. Various campus improvements, a forthcoming website upgrade, a push to celebrate inclusivity, partnership developments, and fostering an environment for both students and employees to succeed were among other topics discussed.



"The heart and soul of this campus is sitting here in this auditorium today," Pellett told the faculty and staff in attendance. "You are the DNA of Glenville State College."

"There is great opportunity for Glenville State to not only survive, but to thrive. I urge you all to help one another and strive forward," Pellett added.
