## **Public Comment**

Professor Rick Sypolt disseminated a report and letter to the Board. He discussed challenges and accomplishments of the Department of Land Resources.

## **Hayflich and Steinberg Presentation**

Mr. Rick Eskins and Mr. Chris Tilsley, Auditors, Hayflich and Steinberg, presented the auditors' reports and discussed GCS's financial statements for the years ended June 30, 2004 and 2005. The financial statements were distributed to the Board.

## **President's Report**

- **a. Report on Staff Activities** Mary Alltop reported that classified staff held a fund raiser, raising \$250.00. She also noted a brochure is being put together for legislators.
- **b.** Report on Faculty Activities Dr. Joe Evans thanked the Board for their letter in support of the Annual Experience Increment (AEI). He noted that ACF put together a legislative agenda and he will present it to the Board at its next meeting.
- **c. Report on Student Activities** Marissa Thrasher announced that Greek Council has been reestablished to assist the Greek organizations on campus.
- **d.** Update on Enrollment Data President Freeman referred to pages 7 and 8 in the Board book. He noted that GSC's headcount had increased 5.5% and FTE increased 5.8% as compared to last year. He announced registration for spring is going well and anticipates over 1200 students enrolling for spring. He also indicated retention was up this fall.
- e. Update on Residence Life Ms. Cheryl McKinney and Mr. Jerry Burkhammer presented a PowerPoint presentation on residence life. Many updates were reported in residence life including residence hall occupancy percentage increase, improvements to facility, new security systems, new shuttle van, etc.
- **f. Report on GSC Foundation Inc.** President Freeman reported the Alumni held two Christmas celebrations with over 100 individuals in attendance. He announced that the GSC Foundation is now the owner of the Rice annuity in the amount of \$532,000.00. He further announced Higher Education Day at the Legislature has been scheduled for February 15, 2006.

## g. Construction/Planning Update

- *Robert F. Kidd Library* President Freeman noted the library is nearing completion and he is planning to take the Board to tour the facility in the spring.
- Mollohan Campus Community Center President Freeman reported that great progress has been made in the construction of the community center and much of the exterior work has been completed. The first meal is expected to be served shortly after January 10<sup>th</sup>. He announced that the students voted to name the cyber café, "Rusty Musket" and the hot food area, "Mollohan's." He anticipates the first and second floor being completed by early January.
- *Health Sciences Center* President Freeman announced that GSC will be building a new health sciences center in the current location of the Physical Plant. He noted that GSC plans to ask HEPC for assistance to renovate the old science building to use as classrooms.

- **Update on Compact** President Freeman made reference to pages 9 and 10 of the Board book and noted that GSC made progress on each of the compact goals.
- WVIAC Equivalency Chart for 2004-2005 President Freeman noted the comparison chart on page 11 of the Board book and indicated that GSC ranks 12 out of 15 schools that give aid to student athletes. He further noted that GSC competes very well in the conference in spite of the fact that we do not offer nearly as much athletic financial aid as many colleges within the conference.

President Freeman announced to the Board that there are some changes that need to be made to the Board by-laws and those changes will be presented to the Executive Committee at its next meeting.

#### **Committee Reports**

#### Committee of the Whole

President Freeman asked Dr. Kathy Butler to discuss the program review for forestry.

Dr. Butler discussed the recommendation to postpone the Forestry A.S. program review for one year due to the timing of the Society of Foresters recognition self-evaluation process.

IT WAS MOVED BY FRED RADABAUGH THAT THE BOARD OF GOVERNORS APPROVE ONE-YEAR POSTPONEMENT OF THE FIVE-YEAR PROGRAM REVIEW FOR ASSOCIATE OF SCIENCE IN FORESTRY. MARGE BURKE SECONDED THE MOTION.

MOTION CARRIED UNANIMOUSLY.

President Freeman asked Dr. Kathy Butler to discuss the program reviews for specific teacher education programs.

Dr. Butler discussed the teacher education program rotation schedule and noted GSC's Policy 26 provision that states programs accredited by specialized accrediting or approving agencies will be considered to meet the minimum requirements of the review process and NCATE has reviewed the programs.

IT WAS MOVED BY FRED RADABAUGH THAT THE BOARD OF GOVERNORS APPROVE THE NATIONAL APPROVAL PROCESS IN LIEU OF A FIVE-YEAR REVIEW FOR SPECIFIC GSC TEACHER EDUCATION PROGRAMS AS PROVIDED IN GSC ACADEMIC POLICY 26. TOM MCPHERSON SECONDED THE MOTION.

MOTION CARRIED UNANIMOUSLY.

Draft Academic Calendars were included in the Board books as information items. President Freeman asked Dr. Kathy Butler to discuss the draft calendars.

Dr. Butler reported that in response to student and faculty requests, administrators reviewed the academic calendars recognizing that GSC semesters are longer than other West Virginia institutions of higher education. She noted that GSC may be proposing to include final exam week as part of the 15-week academic semester rather than adding it to the 15 weeks of instruction as is currently the practice.

President Freeman noted the series of steps for the adoption of policies by the Board of Governors and reminded the Board that time must be allowed for constituent groups and the public to comment on the intent to draft, the draft, and the final draft policies.

IT WAS MOVED BY FRED RADABAUGH THAT THE BOARD OF GOVERNORS APPROVE THE PROPOSED BOARD DRAFT POLICIES TO BE SUBMITTED FOR COMMENT FOR A PERIOD OF THIRTY DAYS. TOM MCPHERSON SECONDED THE MOTION.

MOTION CARRIED UNANIMOUSLY.

President Freeman made reference to the proposed amended Board meeting schedule and reminded the Board that due to Higher Education Day at the Legislature on February 15<sup>th</sup>, the Board meeting scheduled for that date should be rescheduled.

IT WAS MOVED BY FRED RADABAUGH THAT THE BOARD OF GOVERNORS APPROVE THE PROPOSED AMENDED 2005-2006 BOARD MEETING SCHEDULE. TERRY BUTCHER SECONDED THE MOTION.
