e. Miscellaneous Updates from the President – President Barr asked Annette Barnette to discuss public relations updates.

Student and Academic Affairs Committee

Sue Morris reported that the committee considered the proposed action items. She asked Dr. Butler to discuss the proposed action items.

Dr. Butler reported that the implementation of a Spanish Minor program will better prepare students for a global economy. She indicated that the program will not only offer students the opportunity to become fluent in a second language, but will serve as the foundation for the language component of a Spanish Education program that is currently being developed.

Dr. Butler further discussed the program reviews and explained the procedures which were followed for the review and evaluation of the proposed academic programs.

YOUR SPOUSE IS HEREBY AUTHORIZED TO SERVE WHEN CALLED UPON AS A REPRESENTATIVE OF THE INSTITUTION, AND TO ACCEPT PAYMENT OR REIMBURSEMENT FROM THE INSTITUTION OR THE GLENVILLE STATE COLLEGE FOUNDATION, INC. FOR EXPENSES INCURRED IN CONNECTION WITH SUCH ACTIVITY, INCLUDING TRAVEL ON BEHALF OF THE COLLEGE TO THE EXTENT SUCH PAYMENTS ARE AUTHORIZED BY YOU OR THE FOUNDATION, AND IT IS UNDERSTOOD THAT YOUR SPOUSE MAY USE FACILITIES AND OTHER RESOURCES OF THE INSTITUTION IN THE SAME MANNER AS AN EMPLOYEE WHEN INVOLVED IN SUCH ACTIVITY.
