He announced that Mr. Stan Pickens resigned via letter to Sue Morris dated December 12, 2011 and assured the Board that Mrs. Morris would be working diligently to submit new appointment suggestions to the Governor.

Hayflich & Steinberg Report

Mr. Mike Hager, Auditor for Hayflich & Steinberg presented the College's audit report previously provided to the Board at its last meeting. He further discussed each page of the audit report booklet and offered to answer questions.

Mr. Tim Butcher asked if the GASBE39 requires all Universities to report their Foundation's financials.

Mike Hager indicated that yes, all are required.

Department of Fine Arts

Professor Lloyd Bone referred to the Fine Arts updates in the Board book and discussed the following:

- He reported that the percussion ensemble is planning another tour this year. The three to four day tour will include the Parkersburg and Belpre, Oh areas.
- The department just purchased a xylophone and marimba. It has been twenty years since the two instruments have been replaced.
- Mr. Bone announced that the Bluegrass band plays every Thursday night at the Pioneer Grill.
- The All-State Choral Clinic will be hosted by Glenville State next Friday.
- Dr. Lewis is working to try and bring a state jazz band clinic to the College.
- The Tuba and Euphonium Ensemble was one of twenty groups recently invited to perform at the 2012 International Tuba and Euphonium Conference in Linz, Austria this coming June.
- Mr. Bone thanked President Barr and Jason Phares for the purchase and installation of the new Fine Arts sound system.

Dr. Peek asked if an academic honor society for music will be implemented. Mr. Bone indicated that it will be added.

Dr. Peek announced that the Higher Education Policy Commission will be voting on the Bachelor of Arts Art degree program on February 17th that was approved by the Board of Governors at its June 8, 2011 meeting.

Updates

Mr. Heffelfinger thanked all who submitted updates for the Board book and invited members to offer comments and ask questions.

There were no questions from the Board.

President's Report

President Barr provided a partial list of activities to the Board that he has been engaged in since the last meeting.

- He reported that he made a presentation at the WVASA (WV Association of School Administrators) meeting on January 26, 2012. He plans to schedule meetings with the remaining thirty-five county superintendents in West Virginia that are not yet in the Consortium and offer all to join. He hopes to expand the program state-wide.
- A summit will be hosted by Glenville State College in the summer to allow for college faculty and K-12 teachers to communicate and collaborate in various areas including curriculum standards.
- If funding is available, Chancellor Noland agreed to allocate \$200,000 a year from innovation funds to the JASON Project budget at Glenville State College for the next five years. He also agreed not to oppose a \$100,000 increase in the base budget for the Hidden Promise Consortium budget. President Barr met with the Interim Chancellor Paul Hill and Dr. Hill has committed to the same funding if the Higher Education Policy Commission is granted the funding.
- President Barr met with Delegate Boggs and Senators Facemire, Edgell, and Kessler regarding the JASON Project and Hidden Promise Consortium.
- He announced that Stonington School District in Mystic, Connecticut will be joining the Consortium in the near future.
- During a recent meeting with the Alumni Council, President Barr asked all to let him know where there may be out of state opportunities to expand the Pioneer Scholarship Program. He requested the same from the Board of Governors.
- Dr. Barr requested that Ms. Barnette provide an update to the public regarding the construction of the Pioneer Center. He indicated that the College hired new engineers and is soliciting rebids. The bid advertisement will go out on March 9th. Work is scheduled to begin on May 1, 2012 and the Center is expected to be completed by May 2014.

Mr. Peck inquired as to whether it may be possible to link the Appalachian Scholarship with the Hidden Promise Scholars Program and broaden it to other areas.

President Barr responded that he thought it would be an excellent approach to broaden it out of state and noted that he would work on it and bring it back to the Board for approval.

NCATE Accreditation Update

Dr. John Peek reported that Kevin Cain provided the NCATE Chart of Program Review Process that was presented to the Board. Dr. Peek discussed the chart and referred to the bottom of the first page noting the explanation of issues previously raised. He announced that the NCATE visit is scheduled for March 31, 2012.

Announcements

Vice Chairperson Heffelfinger announced that Dr. Gary Morris will be presenting a report regarding the Department of Science and Mathematics at the Board's next meeting.

He reminded the Board that the next scheduled Executive Committee meeting is Wednesday, March 28th at 11:00 am and the next full Board meeting will be on Wednesday, April 11, 2012.

Ms. Jennifer Wenner spoke briefly to the Board regarding her past experience with broadcasting.

Dr. Peek introduced Professor Dennis Wemm and noted that he is working on a Communication Arts degree program. Mr. Wemm has also been working with the new TV/Radio Station.

Mr. Heffelfinger invited all to tour the new TV/Radio Station with Jennifer Wenner directly following the meeting.

With no further business and hearing no objection, Vice Chairperson Heffelfinger adjourned the meeting at 2:00 p.m.
