

Independent Student Verification Worksheet 2019-2020

Your 2019–2020 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, a comparison of your FAFSA with the information on this worksheet will be done along with any other required documents. If there are differences, your FAFSA information may need to be corrected. You, and spouse, if married, must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to our office. Additional information may be requested. If you have questions about verification, contact our office as soon as possible so that your financial aid will not be delayed.

C. STUDENT TAX RETURN FILERS
Important Note: If you filed, or will file, an <u>amended 2017 Federal income</u> tax return, you cannot use the IRS Data Retrieval Tool. You must request a <u>Return Transcript</u> and an <u>Account Transcript</u> at <u>www.IRS.gov</u> , or call 1-800-908-9946. If you have been the victim of identity theft, please contact our office for instructions.
Read Instructions: Complete this section if you (or your spouse, if married) <u>filed or will file</u> a 2017 income tax return with the IRS. The best way to verify income is by using the IRS Data Retrieval Tool that is part of the FAFSA on the Web. If you have not already used the tool, go to <u>FAFSA.gov</u> , log into your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2017 IRS income tax information into your FAFSA. For electronic filers, it takes up to two weeks for IRS income information to be available to use with the Data Retrieval Tool and up to eight weeks for paper return filers.
Check the box that applies: I have used the IRS Data Retrieval Tool in FAFSA on the Web to retrieve and transfer my (and, if married, my spouse's) 2017 IRS income information into my FAFSA, either on the initial FAFSA or when making a correction to the FAFSA. (The school will use the IRS information that was transferred in the verification process.)

To obtain an IRS tax return transcript, go to www.IRS.gov and click on the "Get Your Tax Record" link, or call 1-800-908-9946. Make sure to request the "IRS tax Return Transcript" You will need your social security number, date of birth, and the address on file with the IRS (normally this will be the address used when the 2017 IRS tax return was filed). It takes up to two weeks for IRS income information to be available for electronic IRS tax return filers and up to eight weeks for paper IRS tax return filers.

Check here if your (and, if married, your spouse's) 2017 IRS tax return transcript will be submitted to the school later. Verification cannot be completed until the 2017 IRS tax return transcript has been submitted to the school.
