Participants must pass a swim test at the first class, the test consists of:

1) A 300-meter continuous swim (six laps in a 25-meter pool, up and back is one lap) using either the front crawl (freestyle) or the breast stroke. This is not timed, but participants are not permitted to stop until all laps are complete.

2) Treading water, hands free, for two minutes in the deep end of the pool (hands cannot be used to skim or paddle in the water).

3) Brick retrieval to be completed within one minute, forty seconds. Starting in the water, swim 20 yards. The face may be in or out of the water. Swim goggles are not allowed. Surface dive, feet-first or head-first, to a depth of 7 to 10 feet to retrieve a 10-pound object. Return to the surface and swim 20 yards on the back to return to the starting point with both hands holding the object and keeping the face at or near the surface so the swimmer is able to get a breath. Candidates should not swim the distance underwater. Exit the water without using a ladder or steps.
