## Glenville Pioneers Blast University of Charleston to Claim WVIAC Championship!!

On November 8<sup>th</sup> our Glenville State Pioneers (8-3, 7-1) broke open a close game with 17 points in the final 35 seconds of the first half as they claimed their first WVIAC title since 2001 at Morris Stadium, with a 50-20 win against Charleston (7-4, 5-3).

ALL WVIAC honors were given to Jerry Seymour, who rushed for a pair of touchdowns and 237 yards on 36 carries, establishing a new WVIAC single season rushing record with 2282 yards on the season. The Central Michigan transfer and Harlon Hill regional finalist, ends his GSC career sixth on the WVIAC ALL-TIME rushing list with 3996 yards in only 22 career games as a Pioneer. He was named the League's Offensive Player of the Year.

Additionally, GSC Head Football Coach Alan Fiddler was named WVIAC Coach of the Year.

**Candice Silberschatz '08**, a Houston, TX native, received the Clarissa Williams Award during Homecoming 2008. This award is given annually to the College's top female athlete. Candice was a four year member of our volleyball team and team captain her senior year. 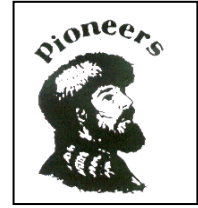

## Jim Rogers Donates Third Pioneer Rendering

**Professor Emeritus James W. "Jim" Rogers '63** has sketched another Pioneer for his alma mater, this one being a full figure version. A former Pioneer (1962), Jim originally drew the pioneer head that continues to be used in athletic, alumni and marketing publications for his friend and former Athletic Director, Joseph Now, in the early 80's. In the mid 90's, he drew a second version of the Pioneer at the request of then GSC Bookstore Manager (now Alumni Director) Debbie Nagy. This version is also used in athletic, alumni and marketing publications and a bronze replica of it is on GSC's Athletic Hall of Fame Wall in the Physical Education Building and carved in the President's Mace, which is used in all College formal ceremonies.

Last fall, again at the request of Debbie Nagy, Jim drew a full figure version of the Pioneer to be used in College publications (including recruiting brochures) on campus signage, mementos, etc. These drawings were done at no cost to the institution, another example of how our alums so willingly give back of their time, talents and resources to their alma mater.

He only asked that he be sent one of each way these drawings are used. Thanks, Jim for these three different sketches of the Pioneer and continue to watch your mail for more examples of how we use these sketches. Please know that you are appreciated!!!

She received her Master of Arts degree at Marshall University and took her Doctorate of Education from West Virginia University. Dr. Garrett earned the title of Professor of Business at GSC and served as Chairperson of the Department of Business during the academic years of 1993-2001 and 2003-2008. Additionally she served as Vice President for Enrollment Services from 2001-2003 and was a faculty marshal from 1999-2001.

Mr. Hinter retired from Glenville State College in August 2007 after teaching at his alma mater for 35 years. He received his Masters of Business Administration degree at Marshall University and is a Certified Public Accountant. Mr. Hinter earned the title of Associate Professor of Business Administration at GSC. He served as an academic advisor and was an advisor to various student organizations. Mr. Hinter is held in high esteem by the accounting majors he taught through the years and he keeps up with many of them who have gone on to do well in their established careers.

## GSC Inducts Five into Curtis Elam Athletic Hall of Fame

On Saturday, May 17, 2008, Glenville State College inducted five individuals to its Athletic Hall of Fame, which was established in May 2001 through the generosity of the late **Curtis Elam, a 1949 graduate**.

This year's inductees were:



**Russell Porterfield** a native of Richwood. Russell graduated from Glenville State Teachers College in **1939**, lettering in basketball and football. He competed for the legendary **Coach Nate Rohrbough** and led the Pioneers to their first WVIAC football title in 1937. Additionally he earned ALL

Conference football honors in 1938. Russell was a veteran of WWII where he was awarded a Silver Star for bravery. He went on to become a very successful high school football coach at Webster Springs High School, his record being 125-18. After relocating to Macclenny, FL, he once again enjoyed much success in his coaching career, winning the State's High School Conference after 60 wins in a row. He later served as a high school principal in Florida for many years. Russell and widow, **Mary Helen Smith '40**, are both deceased. They were parents of two sons, **John Porterfield '69** and **Steve Porterfield '75**. John accepted posthumously for his father.

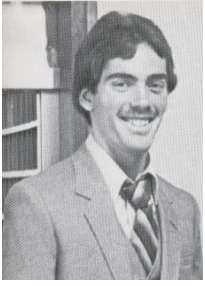


**Bob Armstrong** a native of Warren, OH Bob graduated from Glenville State Teachers College in **1942**, lettering in basketball. In his freshman year, Bob was sixth man on the team and the next three years, a starter and team leader. He was co-captain of the team his junior and senior years and competed for

Coach Rohrbough. His team was Three Time First Team ALL Conference, twice competing at the national tournament in Kansas City, where they won third place one time and second place the other. They could have gone to Kansas City a third time but the Coach turned down the invitation in 1942. Bob was Two Time ALL Conference in 1941 and 1942. Additionally, he was named All Tournament in 1942 and named to the 50<sup>th</sup> Anniversary (1924-1974) ALL Time ALL Conference WVIAC Team. He received a master's degree from Kent State University, taught and coached in high schools then worked in the insurance business and owned a private business in real estate until his retirement in 1998. Bob is a veteran of WWII and spent 18 months overseas in Counter Intelligence. Bob and his wife, Phyllis, reside in Jacksonville, FL. They are parents of three daughters: Robyn Moronti, Pat Frank and Leslie Post who live near them. His daughter, Leslie, accompanied him from Florida and was by his side at the podium during his induction.

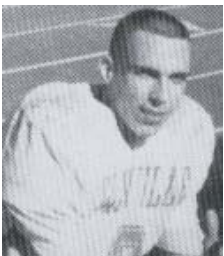


**Coach Earl "Whitey" Adolfson**, a native of Belmont and who spent much of his young life in Weston. He "walked-on" with West Virginia University's football team in 1949 before transferring to West Virginia Institute of Technology where he started as center and linebacker from 1950-1953 and graduated in 1954. "Whitey" received his Master of Science degree in Physical Education from West Virginia University in 1962 then taught and coached in Lewis and Wirt County schools and at Southern High School in Oakland, MD before coming to GSC in 1966 as an instructor and assistant football coach. He was defensive coordinator for the Pioneers from 1968-1974 and celebrated the 1973 team's NAIA Football National Championship Runner-Up honors. Additionally he was assistant basketball coach in 1966 and revived the College's wrestling program from 1968-1975. He was Head Football Coach from 1975-1979 and continued teaching and served as Assistant Athletic Director from 1980-1985. After 30 years of teaching and coaching, he pursued a career with I. L. Morris Well Service until his retirement in 1993. Respected by his fellow coaches and student athletes, "Whitey" has been a loyal GSC advocate for over four decades. He received the 1996 West Virginia Coaches Association's "Retired Coach of the Year" honors for his contributions to coaching and was branded "the Players Coach". Now retired, he continues to be one of the Pioneer's biggest fans. "Whitey" and his wife, Jean, now deceased, are parents of two daughters **Tanya Barker '73** and **Machelle "Shelly" Stalnaker '77**, one son, Greg Adolfson and three grandchildren, Daphne and Tyler Stalnaker and Brett Barker. Both son-in-laws, **Charles "Chuck" Barker '79** and **Lynn Stalnaker '80**, played football for "Whitey" at Glenville State College.



**Steve "Reno" Gandee**, a native of Clendenin. Steve graduated from Glenville State College in 1982, lettering in football and baseball. He received Honorable Mention ALL WVIAC in football during his senior year and was the team's captain. "Reno" scored a total of 127 points for the Pioneers, compiled 698 yards and

had 8 touchdown receptions on 40 pass catches in his career. Additionally, he established a then school record 47 yard field goal. Steve finished his four year baseball career with a winning pitching record and was captain of the baseball team in 1981 and 1982. While at GSC, "Reno" served as a student representative on the athletic committee, was a resident assistant and then a head resident assistant. After completing his student career at GSC, Steve remained at Glenville as a housing director while serving as a graduate assistant football coach in 1982. After receiving his Masters Degree in Business Administration from WVU in 1985, he returned to his alma mater as a visiting instructor in the Division of Business and also served as an assistant football coach. Additionally in 1985, he completed the WVSSC mandated basketball officials training program which led him to his current 24 years of officiating basketball at the high school level and his 14<sup>th</sup> year at the WVIAC Level. In 2001, Steve was selected as the National Federation Officials Association Boys Basketball Official of the Year for West Virginia. He currently is secretary/treasurer for the WVIAC Basketball Officials Association. Steve received his Juris Doctorate in 1989 and has, on occasion, served as an adjunct professor at his alma mater, teaching among other subjects Business Law based on his experience as an attorney in West Virginia. He currently serves as Chairman of the Department of Litigation for the statewide law firm of Robinson & McElwee, PLLC. He is married to the former **Tamra "Tammy" Burkhamer '83**. The Gandees have two children, Stephenee and Andrew. They reside in Jane Lew.



**Carlos Ferralls** a native of Miami, FL. Carlos graduated from Glenville State College in 1998 lettering in football. He was a three time WVIAC ALL Conference Performer and a three Time ALL American. The Pioneers played in the NAIA during his freshman year.

The three subsequent years were played in the NCAA. The 1998 official NCAA record book lists Carlos as being fourth in the nation in ALL Time Receptions per Game with 10.1. During his playing career for the NCAA, Carlos was first in ALL Time Career Receptions per Game with 268 and fourth in ALL Time Career Yards per Game with 120. In 1996 and 1997, he led the nation in receptions per game

and in 1997, he led the nation in yards per game. He was awarded the College's prestigious Montrose Award in 1998, his career stats being 268 receptions, 4101 yards and 46 touchdowns. After returning to his native Florida, he worked at the YMCA for two years "giving back" to the community before coaching football and teaching four years at Miami Senior High School. Carlos currently serves as Administrative Assistant to the Assistant Principal for the Miami Dade County Public School System where he handles among other duties, curriculum and attendance. He recently received a Masters Degree in Leadership and Administration and has career goals to become a principal and later a superintendent. Carlos and his wife, Belkis Ferralls, reside in Coral Gables, FL. In accepting his recognition, Carlos paid tribute to his former coach, by saying "Coach Rich Rodriguez taught me how to be a champion. It is because of him that I am here today as an Inductee to the Hall of Fame. I am living the American dream. Glenville State College helped give that to me," said Ferralls.

The tradition of each nominee selecting their presenter was observed with Inaugural Inductee **Frank Martino '38** saying a few words about **Russell Porterfield '39** and then introducing Russell's son, **John Porterfield '69**, who accepted posthumously for his father. Lifelong friend, **Jack Conrad '51** introduced his good friend and former team member, **Bob Armstrong '42**. Greg Adolfson introduced his father, Earl "Whitey" Adolfson with Hall of Famer **Bill Hanlin '50** and **Rick Trickett '74** offering congratulatory remarks as well. Former Head Women's Basketball Coach, former Head Men's Golf Coach and Hall of Famer, **Tim Carney '62**, brought introductions and congratulatory remarks for **Carlos Ferralls '98**.

Plaques of all Curtis Elam Athletic Hall of Fame inductees are displayed on the Hall of Fame Wall in the lobby of GSC's Physical Education Building.

# Conrad Family Business 1927 – 2008

Purchase of the Conrad Motel by the Glenville State College Housing Corporation on July 1, 2008 marked the closing of a family business, spanning more than 81 years in Glenville. Leland and Hallie Conrad and their two children, **Madelyn '42** and **Jack '51** moved from their farm on Turkey Fork of Dusk Camp in 1926 and by 1927 had bought a restaurant. Jack remembers standing on a stool and washing dishes by the time he was seven years old and Madelyn became a very young waitress.

The Crystal Restaurant stood on the south-western corner of the current Conrad Court and Powell Street. The small ramshackle building was purchased from Okey McCartney. It had four small tables and a counter with nine stools. After a difficult beginning, the Conrads were able to purchase adjoining land and build their own restaurant.

The next expansion saw the beginning of their hotel business. It consisted of adding a second floor in 1934, with rooms to rent. Over time, they added on to this modest building until they had a full-scale hotel with 64 units and a coffee shop. The Crystal Restaurant had long ago lost its name and became the hotel dining room. "Mom" and "Pop" Conrad were popular hosts and became well known for their pies. Hotel guests of note included Lowell Thomas and Eleanor Roosevelt, who at different times, were speakers at the Glenville State Teachers College Lyceum programs.

The family business was expanded in 1947 to include taxi service. In 1966, Mr. and Mrs. Conrad built the first wing of the existing Conrad Motel, which Mrs. Conrad managed while her husband continued to oversee the hotel. At the motel, Mrs. Conrad doted on the "girls" who cleaned the rooms and she took them to lunch on Wednesdays. Mr. Conrad lost his eyesight to macular degeneration and retired from the hotel in 1983. He sold that building, including the restaurant, and moved across the street to their apartment in the motel. He passed away in 1985.

After more than forty years of working seven days a week, the elder Conrads began to have health problems. Madelyn and Jack had helped their parents as long as they were living in Glenville, but both married and moved away.

After Jack's discharge from the Army in October, 1945, he and his young family moved back to Glenville and the business. After

receiving his BA from Glenville State College in 1951, they moved away again, this time to Morgantown. Jack taught at Morgantown High School and earned his Masters in Educational Guidance from West Virginia University.

It was in 1973 that Jack was asked by his parents to return to Glenville and bring the management up to date. He took a leave of absence from his position as guidance counselor at Fairmont State College, and he and his wife, **Jo Bush Conrad FS '41**, moved back to manage the Conrad businesses (hotel, motel and taxi) for four years. They lived in two rooms at the motel for 50 months. Although Madelyn lived in Gassaway, she also pitched in to help.

Mr. Conrad's health improved and in 1977 Jack returned to school work at Potomac State College, Keyser, WV. In 1985 he retired from there and in 1987, he moved back to Glenville, working with the motel. By this time Jack had also acquired macular degeneration.

When Mrs. Conrad died in 1988, Jack and Madelyn inherited the business. Jack and his wife Jo moved into the motel apartment and resumed active management, with the efficient help of his mother's "girls" and manager Thelma Norman. When Madelyn passed away in 1998, her daughter Sue Shipe of Albany, New York, inherited her mother's half of the business. Early in 2008, Jack and Suzie agreed that it was time to let it go.

Now that Jack has finally retired, he remains in his motel apartment and there is no obvious change. All of the same people are employed by the College and the motel is still in operation. Much did change over the years from 1926 to 2008, and much will certainly change over the coming years, but Jack Conrad is relaxed about that. He knows that his motel is in good hands with Glenville State. He observed, "My niece, Suzie, said it best when she wrote of the feeling that the property is being passed into the secure hands of College President Pete Barr."

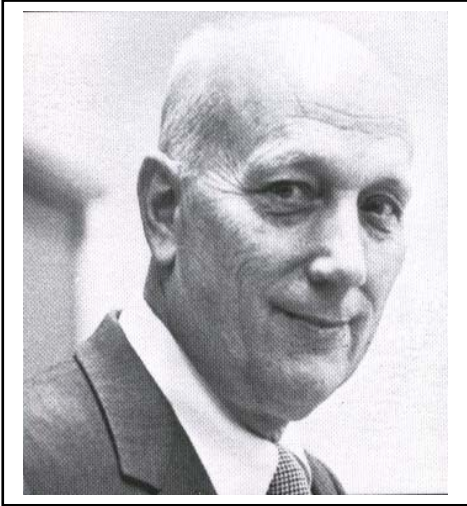
The College will utilize the motel to support its alliance with the Department of Military Affairs and Public Safety in the training of law enforcement officers. "The Conrad is a Glenville institution and it will continue to operate as it has in the past, as a public motel. We will use the Conrad to house cadets during their training here at Glenville State College. This is a big step that will help us expand this training program," said GSC President Peter Barr.

Over the years, the Conrad has served a vital role in the local economy. The families, friends and alumni of Glenville State College have depended on the Conrad for many occasions, including commencement and homecoming. The oil and gas industry frequented the motel during the boom in the 1960's and 70's. Getting a room at the Conrad for the West Virginia Folk Festival each June is nearly impossible; there has been a waiting list for years. A gentleman's agreement will allow the continued use of the motel by the public for the Folk Festival.



## Alum Remembers Professor Emeritus Espy Miller

Glenville State College has lost another of its own, retired Professor Emeritus Dr. Espy W. Miller, who passed away on October 6, 2008.

Dr. Miller and his wife, Roselea, moved to Gilmer County in 1946 when he began his remarkable career as an English professor at Glenville State College. Until his retirement in 1976, he distinguished himself as a teacher and as Chair of the Department of English and Foreign Language. Dr. Miller taught many courses including Chaucer, Shakespeare and Mythology. His effectiveness in the classroom is legendary. Returning alums often spoke of his vast knowledge and enthusiasm for language and literature while maintaining the highest academic standards. More importantly, they always noted how he encouraged them to continue their educational lives and service to others beyond Glenville. Dr. Miller touched and enriched the lives of many young men and women through his career at Glenville State College. He embodies all the qualities which make Glenville State's faculty among the best of any college or university.

### TRIBUTE TO DR. ESPY W. MILLER

I was saddened to learn of the death of Dr. Espy W. Miller. As I recount the events and people who have affected my life and professional career, Dr. Miller stands in the forefront. He not only was a terrific, well-prepared classroom instructor, he was a valued mentor and counselor. At four crucial times in my life he said the right words and gave the needed encouragement when I was about to make a decision or pursue an endeavor.

This first such happening occurred at the end of my sophomore year at GSC. I had taken a world literature class that he had taught. I learned much and enjoyed the class very much. I had chosen my first teaching field (social studies) but had not selected my second one. As we handed in our final exam papers, he said, "Mike, have you selected your second teaching major?" I stated that I had not. He said, "We in the English Department would be happy to have you as a major." Such words coming from the Chairman of the Division of English and Foreign Language were almost overwhelming. English became my second major and Dr. Miller became my advisor for that program. Later, because I had a second major in English, I was able to begin my career teaching social studies and English.

The second incident happened one year later as I campaigned successfully for the student government association presidency. He stopped me after class one day and said, "Mike, faculty can have no say in student elections; however, I want you to know that we in the English Department would not be unhappy to see you elected."

The third incident happened shortly before graduation. I had not yet secured a teaching job and was becoming somewhat apprehensive. Again, he stopped me after class and asked if I had gotten a job. When I told him that I had not, he informed that a school superintendent had contacted him about a job vacancy and asked for a referral. He took me to the English and Foreign Language Office and made the contact. After I had finished talking with the superintendent, I informed Dr. Miller that the man had asked if I would eventually be interested in school administration. He said, "Mike, one day you will have to choose whether you want to teach or be an administrator." I was surprised that he could see me as an administrator. He explained that he too had to make that choice. He told me of an administrative position that he had been offered at another college and said that he had stayed at Glenville because he loved the classroom. Later, I became an administrator and spent almost three-fourths of my career in that work.

The final incident occurred also shortly before my graduation from GSC. Dr. Miller had been asked to give the commencement address at my high school alma mater, Burnsville High. He asked that I accompany him. He introduced me as a model of a student who graduated from a small high school and achieved success in college. On the way back to Glenville, he asked if I had plans for graduate study. I told him that I did. He encouraged me to pursue a doctorate. Seventeen years later I received my doctorate in education from West Virginia University.

My tribute to Dr. Miller is not unique; it is illustrative of his impact on the lives of many students and colleagues. He truly loved and cared about people. He had a special love for Glenville State College even though he was a Concord alumnus. His feeling for Glenville State can best be summarized by Daniel Webster's famous peroration in the Dartmouth College case. Referring to his alma mater, Webster said, "It is, sir, as I have said, a small college. Yet there are those who love it!"

## 1908-2008

### 100 Years of Football and Men's Basketball at Glenville State College

The following text appears in Kent Kessler's book entitled Hail West Virginians! This book, containing chapters on when each College in West Virginia started competitive sports was copyrighted and published by the author in 1959. Copies of this book are available for your reading enjoyment at GSC's Robert F. Kidd Library.

*Glenville College was established in 1873 and did not become interested in athletics until 1901. During the early years the students were not allowed to participate in athletics of any kind; the faculty believing that sports were unnecessary. In 1900 three students were expelled for attending a dance. We can imagine the boys slipping off to pitch horseshoes and smoke cubebbs but it was risky business!*

*In 1901, Edward G. Rohrbough joined the faculty and organized a football team. He had played at Allegheny College and knew that Glenville students needed sports to work off their excess energy. He had the boys clear off a corn field and started practice. The boys had no uniforms but used their old clothes. Some unruly boys were ejected from the field for throwing cornstalks at the players.*

*Mr. Rohrbough tried to arrange games but found none of the schools willing to make the long trek to Glenville. He arranged for his team to play Wesleyan but heard that Wesleyan might run in ringers and cancelled the game. Without outside competition the boys lost interest.*

*In 1908 interest in sports was revived and a football team was organized. The boys made their own uniforms by padding old clothes with rags. A few boys bought nose guards and shin protectors because they were the cheapest items in the Sears & Roebuck catalogue. There weren't enough boys to scrimmage properly but with eight men to a side, the boys got in some good practice sessions. Each afternoon, the boys practiced with almost the entire student body on the sidelines. The girls made pennants and organized a cheering section. A shower was installed in the basement of the administration building by tying a watering can nozzle to the pipes.*

*Glenville played two games, defeating the Elkins All Stars 8-0, losing the second game to D & E 5-0. To take the trips the team rode a ferry-boat up the Little Kanawha River to Gilmer Station to catch the train. It was a great experience as most of the boys had never been outside Gilmer County. Most of them had never been on a train and the boys "lived it up" at Elkins YMCA. They had interesting stories to tell their less fortunate friends about the great outside world. The players were H. Hays, E. Berkhouse, T. Berkhouse, W. Hopkins, R. Bell, M. Cooper, W. Cooper, C. Morris, H. Stearn, M. Evans, R. Mick, C. Cox, K. Chenoweth, O. Bush and C. Bass.*

*That fall, a basketball team began practice on a tennis court and when the weather got bad moved inside into an old assembly hall which had been converted into a gymnasium...*
