New \$28-Million Dorm Project Underway

Demolition crews razed the Wesley Foundation, TKE House, and Physical Plant Building last fall in preparation for a new dormitory that is well underway at this writing. Building plans are to have the first half of the new residence hall ready for occupancy when GSC's fall term begins in August 2010 with the remaining half of the building to open in January 2011 for the spring term.

BBL Carlton, of Charleston, are the general contractors, in this *design build project*.

The building begins near what was previously the entrance to the Wesley Foundation and extends around the curve and up the hill towards the Alan B. Mollohan Campus Community Center (previously known as the Heflin Student Center and before that, the Pioneer Center). Renovations to the Mollohan Center were completed in 2006.

Excitement is in the air as GSC's administration, faculty, staff, and students eagerly look forward to the new building's competition. It is anticipated that this new modern facility will bring continued enrollment increases to the College.

Pickens Hall will not be coming down, at least not anytime soon. It will fill various facility needs on campus and continue to be used for summer camps.

Kentucky Chapter Event



Although she was away from her Salt Lick District roots in Braxton County for more than half a century, the late **Alice Mulnix Singleton '36** left little doubt about where she considered home. At her recent passing, Alice's estate, combined with what she and her late sister, **Helen Mulnix Hunter '35**, had already established in a scholarship honoring their parents more than twenty years ago, puts the fund total near the top of Glenville State College's many scholarships. Their generosity and forethought will give the youth of neighboring Braxton County the same opportunities these sisters had of receiving a quality education and using that education to build financial stability and a lasting legacy.

The sister's parents were hardworking and successful business people in the Salt Lick district. Their father operated the Marathon Service Station in Burnsville for many years and their mother operated a beauty parlor out of their home.

Alice graduated from Glenville State College in 1936 with a Bachelor of Arts degree in Education and later received her Masters of Education from Duke University. Her long teaching career had many stops before concluding with teaching and eventually retirement in Beverly Hills, FL.

Glenville State College President Dr. Peter Barr said, "This recent gift is further indication of the love that graduates from Glenville State College have for the institution and is a significant addition in our effort to be the first choice of young men and women in Braxton County as they make their college plans. These two sisters, in honoring their parents, have in fact given honor to the way of life that led to their success and will give future generations of students opportunities to take advantage of the increased earnings potential that a college degree can bring."

GSC's Chris George Named to 2010 College Football Hall of Fame Ballot

(DALLAS, TX) Former Glenville State wide receiver Chris George is one of 24 all-time NCAA Division II greats on the 2010 College Football Hall of Fame ballot.

The four-time ALL-WVIAC selection from 1991-94 caught a league-record 430 passes for a staggering 6,177 yards during his Pioneer career. The Clarksburg, WV native also owns the conference record with 52 career touchdown receptions. His 11.5 catches and 160.8 receiving yards per game are still NCAA Division II career standards.

George also has an iron grip on the WVIAC's single season receiving records. His 1993 total of 144 receptions for 2219 yards are still league record marks by a wide margin.

He was a part of two WVIAC championship squads under coach Rich Rodriguez during his Glenville State career and the 1993 Pioneers reached the NAIA national championship game before falling 49-35 to East Central (OK).

The three-time All-American was nominated for the College Football Hall of Fame by the Don Nehlen Chapter of the National Football Foundation.

To become eligible for selection onto the ballot, players must have received First-Team All-American recognition

during their careers. Players become eligible ten years following the completion of their career. The announcement of this year's class will be made on May 27th.

Faculty Spotlight

Glenville, WV—
Glenville State College head football coach Alan Fiddler was among five new inductees to the Musselman High School Hall of Fame during an enshrinement ceremony held Saturday evening September 12, 2009 at Musselman High School in Berkley County. Fiddler was unable to attend the festivities because his Glenville State College Pioneer football team was playing Seton Hill University in Greensburg, Pennsylvania that day.



“It is a great honor and I am very humbled to be named to my High School’s Hall of Fame. I was fortunate to have great coaches and teammates at Musselman High School. I was also blessed with tremendous family support throughout my career,” said Fiddler.

A 1984 graduate of Musselman High School, Fiddler was a member of the 1982 West Virginia High School State championship football team and quarterbacked the Applemen to a state runner-up finish in 1983. He was also a standout basketball player for Musselman, averaging 17.3 points per game his senior season. Upon graduating from Musselman, Fiddler attended Glenville State College from 1984-87 where he was a quarterback on the Pioneer football team. He completed his Bachelors degree in Education at West Virginia State College in 1989 and received his Masters degree in Education from Shenandoah University in 2002.

Fiddler began his coaching career as an assistant coach at South Charleston and Musselman before taking the Head Coaching position at Moorefield High School in 1993. He led Moorefield to six West Virginia High School State Championships and a state runner-up in ten seasons. Fiddler holds West Virginia’s state coaching records for the most consecutive state championships (4) and the most playoff wins (28) in state history. Fiddler had a career 98-28 record and 28-2 playoff record while at Moorefield. He coached two undefeated teams and had a 30 game winning streak at MHS. In addition, Fiddler coached the North squad to a 20-18 victory in the 2000 West Virginia North-South All-Star game.

In 2004, Fiddler was named the new Head Coach at Glenville State College. His 2008 Pioneers finished with an 8-3 overall mark and won the WVIAC Championship. Fiddler was named *2008 WVIAC Coach of the Year*. He has won more games in his first five seasons (33) at Glenville State College than any other coach in school history.

In his time at GSC, Fiddler has coached such standouts as **Jerry Seymour '09**, **Joey Conrad '06**, and **Antonio Carter '06**. Seymour, a Harlon Hill finalist Running Back, was named the *2008 WVIAC Offensive Player of the Year* and led the nation in rushing with a 207.4 average per game. Seymour also became the school’s all-time leading single season and career rushing leader. Quarterback Joey Conrad finished the 2005 season as a Harlon Hill finalist and became the NCAA Division II all-time leading Passer and Total Yardage Leader. Conrad was also named the *2005 WVIAC Offensive Player of the Year* while breaking four conference passing records. During the 2004 season, Wide Receiver Antonio Carter was named the *WVIAC Offensive Player of the Year*. Fiddler has also coached 23 All-WVIAC first team members during his time at GSC. Fiddler’s 2008 and 2005 offenses and defenses were ranked first in the WVIAC.

Joining Fiddler in the school’s third Hall of Fame class were Longtime Musselman High School football coach Denny Price; former Musselman standout athletes Kip Washington, and Paul Swartz; and contributor Glen Cunningham. Fiddler lives in Glenville with his wife, Amy, and twin daughters, Shelby and Miran. Fiddler also has two sons, Aaron 22 and Ryan 19.

GSC Grad Leading NCHS Marching Band in National Independence Day Parade

Under his leadership the NCHS Marching Band has excelled, winning numerous band competitions and twice being invited to march at Disney World in Florida.

"I credit Glenville State College for preparing me for my career in Music Education. Everything I know and can teach my kids came from my experience at GSC. Professors Lloyd Bone and John McKinney were instrumental in my development as a music teacher and continue to give me support today," said Akers.

Akers selected GSC for his college education after being encouraged to consider the school by his music teacher who was a GSC graduate. He is returning the favor by making sure that his students look at Glenville State College as an option to further their education. Currently a half dozen of his former students are members of the GSC Marching Band.

Although the invitation to march in the National Independence Day Parade is a great honor, it does present the NCHS Band with a daunting task of raising \$60,000 to pay for the trip. The band has faced the task of fundraising before for their trips to Disney World. What makes this effort even more of a challenge is the current state of the economy. "We understand that, for many families, paying for this trip would be impossible so we are leaving no stones unturned in our effort to raise the necessary funds to pay for the trip," said Akers. The band is appealing to the local community for support. Several raffles are being held and a fruit sale is taking place this spring. Letters have been sent to business leaders and political representatives asking for help in meeting their goal. "We know it will take a lot of work, but we are confident that with the support of the community, we can reach our goal and that our efforts will be rewarded with a once in a lifetime opportunity to be part of this July 4th celebration," said Akers.
