b. PEIA

- i. PEIA has proposed to raise the Tobacco tax to \$.45 and of the \$71 Million revenue he is giving PEIA \$ 40 or 45 million. It is a pretty bleak picture. Ann Reed and Sheri Skidmore were the only was at the presentation. All of the cost that have gone up over the last 3 years, PEIA has not got any additional funding. Right now PEIA is \$120 million short in covering expenses.
- ii. There were round of open meeting in October, November, and December
- iii. Different scenarios 50 million raise to PEIA still have to cut benefit they cannot change they employee/employer have to pay because it is written in code. If they want to change this they have to go back in and change the code.
- iv. Co-pay is going up again. Reduce # of prescriptions, drugs, no coverage, massage therapy, increase office visit, specialist visit, and increase deductible or out of pocket of expenses and could go as much as double the cost.
- v. Nothing has been submitted or finalized. Everything has to be done by April because of the renewal in July.

- vi. Not sure if anyone from the college has written a letter of concern but Paul Peck send out emails in regards to PEIA.
- vii. Sheri Skidmore has a list of where to send emails and you can get online and send them.
