Minutes

October 13, 2016

- I. President Ratliff called the meeting to order at 12:32pm
- II. Roll call was taken by Secretary Carr
- III. Swearing in of new members:
 - a. None
- IV. Review of last week's minutes:
 - a. Colten made a motion to accept the minutes as presented
 - i. Nicole second the motion
 - ii. All in favor, the motion passed.
- V. Congressional Forum:
 - a. Brod informed the group that Jennifer Wenner is producing a sexual assault awareness video and she needs people to participate. She would like SGA and athletes as well as other students to get involved with the video. If you are interested you need to contact her or Brod for more details.
 - b. A.J. Howard asked about the bags of mulch that is located near Goodwin Hall. He wanted to know what they were going to be used for. Administrative Liaison Spears stated the mulch as well as the pea gravel located in some areas was going to be spread by some inmate labor that was going to be on campus working.
 - c. A.J. also asked if the game room located in Goodwin Hall was going to be opened back up. Administrative Liaison Spears informed the group the game room will not be opened up. That space will be used as a conference room. There are plans to open the old Small Business Development Center located downtown as a game room that will offer vending machines, a television/lounge area and more. The hold up in getting it completed is a leaking roof.

- XIII. Advisor Comment/Administrative Liaison Comment:
 - a. Advisor Wilson stated he had several students come to him and discuss options for the current fitness center. A discussion was held about the use of the facility by sports teams. Administrative Liaison Spears informed the group that construction on the new fitness center located in the PE building had to be halted in order to upgrade the new area for Admissions. Renovations will resume soon.

XIV. Congressional Forum:
