1. **Name of Organization:** Glenville State College Self-Defense Club (Self-Defense Club)
2. **Purpose of Organization:**
 - a. Objectives of this Organization shall be to:
 - i. The purpose of the Self-Defense Club at Glenville State College is to provide a location and instruction for people who are interested in learning self-defense.
 - ii. The objectives of the Self-Defense Club at Glenville State College shall be to promote fitness and safety, learn self-defense techniques and principles, and practice learned techniques through hands-on instruction.
3. **Types of Classes of Membership:**
 - a. **To Whom Open:**
 - i. Membership of the Self-Defense Club at Glenville State College shall be open to all currently enrolled Glenville State College students in Good Academic Standing, ~~who have paid their Student Activity Fee and all faculty and staff members.~~ (JW) 10-20-16 JDCW
 - b. **When Eligible:**
 - i. Recruitment shall take place throughout the year and membership is open at all times.
4. **Financial Obligations of Members:** The financial obligation of the Members of this Organization is a ~~twenty dollar,~~ \$10.00, membership fee, paid annually on renewal or initial membership. (JW) 10-20-16
5. **Election and Qualification of Officers:** The officers of the Club shall consist of the following:
 - a. President
 - b. Vice-president
 - c. Secretary
 - d. Treasurer

The Qualifications and terms for the Officers of this Organization are as follows:

- a. All officers of the Self-Defense Club at Glenville State College shall be enrolled at least part time at the Glenville State College and possess at least a 2.0 grade point average.
- b. The offices of this organization shall include a President, Vice President, Secretary, and Treasurer. No officer will be permitted to hold more than one officer position. All officers shall retain voting rights, however, the President shall only vote in the case of a tie. Any officer may be re-elected however not for more than two consecutive terms.
- a. Officers cannot reappoint themselves for a second term they must be re-elected by a nomination and a majority vote.
- b. Election of officers shall be made during the September meeting of a given academic year by a plurality vote on individual ballots by all voting members of this Organization, in good standing, present at said meeting.
- c. Terms of officers end the following September meeting in the next academic year.
