- I. President Ratliff called the meeting to order at 12:39 pm
- II. Roll call was taken by Secretary Carr
- III. Swearing in of new members:
 - a. None
- IV. Review of last week's minutes:
 - a. Senator Boswell made a motion to accept the minutes as presented
 - i. Senator Cooper second the motion
 - ii. All in favor, the motion passed.
- V. Congressional Forum:
 - a. Senator Neal informed the group there is a 3 on 3 basketball tournament coming up. If you would like to help contact Trae in Goodwin Hall.
