- I. President Ratliff called the meeting to order at 12:37 pm
- II. Roll call was taken by Secretary Carr
- III. Swearing in of new members:
 - a. None
- IV. Review of last week's minutes:
 - a. Senator LeMasters made a motion to accept the minutes as presented
