- I. President Ring called the meeting to order at 12:32pm
- II. Public Comment
 - i. None
- III. Roll call was taken by Parliamentarian Jones
- IV. Swearing in of new members:

- V. Review of last week's minutes:
 - i. Senator Conrad motioned to accept the minutes.
 - ii. Senator Thomas seconded.
 - iii. Motion passed.
- VI. President's Report (Only the President may speak at this time)
 - i. President Ring updated the Senate on a few things that was discussed at the BOG meeting. He stated that if you wish to see the items discussed, get with him and he will send the information to you.
 - ii. President Ring also commented on homecoming. He mentioned that the BOG were also extremely pleased with how it turned out.
