

Hidden Promise Program Making a Difference

Program now includes 35 school districts in three states

One of the most innovative programs in higher education today is the Glenville State College Hidden Promise Consortium (HPC). The HPC was started by GSC President Dr. Peter Barr five years ago. The Hidden Promise Consortium is an alliance among Glenville State College and public school districts with the goal of improving communication between higher education and K through 12 education. The consortium aims to improve the number and quality of high school graduates including raising ACT scores, increasing the number of students going to college, increasing the number and quality of college graduates, and aligning the K-12 and higher education curriculum.

“The HPC mission is to respond to an urgent need to increase academic achievement and college-going rates while preparing students for college success. This mission addresses statistics showing Hidden Promise Consortium county school districts lag behind the state, the region, and the nation in completion rates,” said Barr.

West Virginia ranks 50th in the nation for residents holding a four-year college degree. Only 25 percent of West Virginians hold at least a two-year college degree. The national average is around 38 percent. In the most rural West Virginia counties, the rate falls to less than half of the national average. Just 29 percent of first-generation students enroll in post-secondary education immediately after high school compared with 73 percent of students whose parents hold a bachelor’s degree. Just 9 percent of students from low-income families are completing college by age twenty-four compared with 75 percent from high-income families. Central West Virginia school districts have a poverty rate average 70 percent greater than the national average (21.25 versus 12.4 percent) and a per capita income average at barely half of the national average.

The HPC, which was formed in 2007 between Glenville State College and thirteen West Virginia county school systems, has now grown to include thirty-five school districts in West Virginia, Ohio, and Connecticut.

“When we first started the program, our hope was that we would be able to convince other counties to join the HPC. We have been extremely pleased with how quickly that growth has occurred. The eagerness of the support and the commitment of the superintendents to the Hidden Promise Consortium has been amazing. We are making a concentrated effort to eventually include all fifty-five West Virginia County School systems in the program. I am certain that more

districts will be joining the consortium in the near future,” said Barr.

Hidden Promise Scholars are students in the eighth through twelfth grades. Selected by county superintendents and principals, these students interact with Glenville State College students and faculty and explore the vistas that a college education opens. Hidden Promise Scholars are mentored by GSC students at their home schools and online. They also can take advantage of online tutoring and academic coaching. GSC hosts free summer camps for each grade level where students work on academics, learn team building and leadership skills, and are exposed to the college

atmosphere. In addition, students and their families are invited to an array of campus visits for sporting and cultural events. There are currently 697 students in grades eight through twelve who have been selected as Hidden Promise Scholars. Over 175 new students will be added to the list during the fall semester.

Upon high school graduation, Hidden Promise Scholars who enroll at Glenville State College receive annual scholarships. The grant is renewable throughout their enrollment at GSC as full-time students maintaining standard academic progress.

There were thirteen original Hidden Promise Scholars enrolled at GSC in the fall of 2007. That number has swelled to 125 who are enrolled today.

GSC Hidden Promise Scholars have the opportunity to attend one or two field trips and events during each year. Participants of the program have

taken trips to New York City; Myrtle Beach, South Carolina; and Washington D.C. as well as a performance of The Nutcracker Ballet in Beckley, West Virginia and events at the Clay Center in Charleston, West Virginia.

“Our partnership is achieving positive results in recognizing and better preparing students to succeed in college,” said Barr. In West Virginia, 39% of ninth grade students will enroll in college. 55% of

former ninth grade Hidden Promise Scholars have enrolled in college. The first-to-second year retention rate is only 55.4% for the overall college student population but is 92.3% for Hidden Promise Scholars. Second-to-third year retention is 91.6% for our Hidden Promise Scholars and only 79.9% for the overall college student population. 100% of Hidden Promise Scholars graduate from college within four to six years.

Project Helps Veterans Share Their Stories

In September of 2011, Glenville State College established the West Virginia Veterans Legacy Project. This project builds on Glenville State College's World War II Heroes Project, which records and preserves the experiences of West Virginia veterans from that specific conflict.

The West Virginia Veterans Legacy Project focuses on collecting, preserving, and broadcasting stories of West Virginia war veterans who served in the Korean War, the Vietnam War, the Persian Gulf War, and the current conflicts in Afghanistan and Iraq. Historically, West Virginia has had, and continues to have, the highest per capita service rate in the United States.

"Veterans' experiences are part of our American being. A West Virginian's story of service complements a collective identity that West Virginians can share. The

Legacy Project is engaging students in realizing cross-generational traditions, values, and norms that characterize the era and the region. Students working with the project are being introduced to a vital segment of West Virginia history, interacting with historians, and developing research skills," said Jason Gum '05, GSC Library Associate and West Virginia Legacy Project Leader.

To date, over two-hundred interviews with veterans and family and friends of deceased veterans have been conducted for the project. The stories they tell and the memories they reveal are creating a living picture of the brutality, confusion, and sacrifices of war.

"In many cases, this

is the last chance to capture the history of our older veterans. It has been rewarding to hear the stories of service that have impacted so many lives in our state and nation," said Dr. Bob Henry Baber, GSC Major Gifts Officer and West Virginia Veterans Legacy Project Director. "Their stories are inspiring."

Vernon Faris of Weston (Lewis County), West Virginia is an Army veteran of the Vietnam War. "When I first got to Vietnam, I went out with a driver in a Jeep. He drove that Jeep as fast as it'd go on these old dirt roads through the jungle. I asked him, 'Why are we going so fast?' As I was bouncing all around, he said, 'It's in case we hit a mine, Sarge. It might kick us out farther, and it won't injure us.' That is when I began to think, 'What have I got myself into?'"

"The fact of knowing that you can get attacked at any moment really prioritized things in my life. I didn't have time to think about home. When you stepped outside the wire,

you worried about yourself and the guys on either side of you. That was it. You just hoped for the best," said Matt Williams of Coolridge (Raleigh County), West Virginia who served in Iraq with the United States Marines.

The first product of the West Virginia Veterans Legacy Project is a stunning thirty-six-piece photography exhibit, 'A Tradition of Service.' The show primarily features photos of living veterans from World War II and through subsequent conflicts up until the present. The photos were taken by award-winning professional photographer Mark Romano, a 1992 GSC graduate. Veterans from the West Virginia Veteran's Nursing Facility in Clarksburg, the VA Hospital in Beckley, and numerous other regions of the state are featured in the show. The exhibit debuted at Yeager Airport in Charleston, West Virginia on September 12th.

The show will return to Glenville State College on Monday, November 5th at 5:00 p.m. when it will open in the Fine Arts Gallery. The West Virginia Veterans Legacy Project's first book, *Heroes Among Us*, a collection of photographs, both new and old, with succinct vet quotes and short stories will be available for the first time

as well. After the traveling photo exhibit closes at GSC, it will be available to museums, art galleries, colleges, and all other appropriate venues for free. The exhibit is already scheduled for shows at the Beckley Veterans Administration Hospital and the West Virginia Press Association Conference in 2013. Additionally, an installation piece for smaller spaces such as business lobbies, city halls, veteran meeting places, and festivals will be available.

A video documentary about the project is being produced that will make its debut on Saturday, November 3rd at the Veterans and Military Ball at 5:00 p.m. in the Mollohan Campus Community Center Ballroom at Glenville State College. The documentary will also be broadcast on West Virginia PBS on Friday, November 9th at 9:00 p.m. and again on Sunday, November 11th at 7:00 p.m.

Baber is also writing and producing 'Morning Stars, A Tradition of Service.' This multimedia theatre production about Mountain State veterans, the heart of the West Virginia Veterans Legacy Project, will be performed at the GSC Fine Arts Auditorium on Thursday, November 8th and Friday, November 9th at 7:00 p.m. each evening. The performance is free and open to the public. ■

In addition to over 200 interviews, the Veterans' Legacy Project has also captured or preserved many pieces of memorabilia including uniforms, photographs, letters, posters, medals, awards, and more.



Expanding the Mission

Summer Summit Brings K-12 and Higher Education Professionals Together

In keeping with the Hidden Promise Consortium (HPC) goal of increasing communication between K-12 and higher education, GSC hosted the Hidden Promise Consortium Summer Summit, 'Overcoming Obstacles: How do We Get There From Here?'. This three-day event in June brought together K-12 educators and higher education faculty and staff from across West Virginia to develop strategies for improving student achievement.

Over fifty secondary school educators from Barbour, Braxton, Clay, Doddridge, Gilmer, Greenbrier, Jackson, Mason, Mercer, Mingo, Pleasants, Pocahontas, Putnam, Raleigh, Randolph, Roane, Upshur, Webster, Wood, and Wyoming Counties, and Belpre, Ohio attended. Glenville State College, Fairmont State University, Concord University, West Liberty University and Shepherd University also had representatives participate.

The summit's first two days identified common characteristics of successful students and developed strategies to promote such positive traits. On day three, superintendents, principals, state education officials, and members of the West Virginia Higher Education Policy Commission listened to the proposed strategies and discussed the Summit participants' deliberations.

A second Hidden Promise Consortium Summit will be held later this year to continue the process of increasing communication between K-12 and higher education so more students with college potential can be identified and given the support they need to be successful college graduates. ■

Athletic Hall of Fame Inductees 5

Four alumni and one coach were inducted into the Glenville State College Curtis Elam Athletic Hall of Fame during the Induction Ceremony and Banquet held on Saturday, May 19th in the Mollohan Campus Community Center Ballroom. The 2012 inductees are Don Bullett '82, Coach/Athletic Director Leland Byrd, Sandra Elmore '73, Steve Taylor '60, and Ed Tekieli '56.

The Curtis Elam Athletic Hall of Fame was established in 2001 through the generosity of the late Curtis Elam, a 1949 GSC graduate. Hall of Fame member plaques are displayed in the lobby of the Jesse R. Lilly, Jr. Gymnasium.

Don Bullett

Don Bullett, a native of Martinsburg (Berkeley County) lettered in basketball four years and in track his senior year for the Pioneers. He was named to the 1980 WVIAC ALL Tournament Team and the ALL WVIAC First Team in 1981 and 1982 as well as ALL Conference NAIA in 1981 and 1982.

During the summer of 1981, Bullett was chosen to play on the Select Team to Australia, being one of only two players selected from West Virginia to participate.

Bullett scored 1,865 career points at GSC, all before the three point rule was instated. He racked up 40 points in GSC's game against Davis & Elkins when Hall of Fame Inaugural Inductee and legendary Coach Jesse R. Lilly, Jr. '48 celebrated his 250th career win. Bullett received the coveted Frank Montrose award after graduating from GSC.

He graduated from Glenville State College in 1982 with a Bachelor of Arts Degree in Education with specializations in Physical Education (K-12) and Safety Education.

“Coach Jesse Lilly was a great man with outstanding character and integrity. He and the faculty and staff at Glenville State College gave me the foundation that prepared me for my career. They made it possible for me to return to my hometown, be successful, and give back to my community. I will be forever grateful for the opportunities that GSC made possible,” said Bullett.

He taught health for seven years and physical education for 24 years at Martinsburg South Middle School and coached during this time at Martinsburg High School. His coaching duties at Martinsburg High School included being Head Girl's Basketball Coach (1983-2004), Assistant Boy's Basketball Coach (1983-1985 and 1997-2008), Head Freshman Boy's Basketball Coach (1986-1993), and Assistant Track Coach (1998-2007).


Bullett's coaching and teaching honors were many during his time in Martinsburg. He received the ACE Award as the school's most caring educator, and the Regional Girls' Coach of the Year Award in 1990-1991, was selected Head Coach of the North West Virginia All-Stars team in 1992, Hagerstown Herald Coach of the Year in 1996, Head Coach Journal Classic All-Stars in 2002, and the West Virginia Coach of the Year on TV Channel 25 Alive in 2003.

His Varsity Girl's Basketball Team record was 323 wins and 127 losses at Martinsburg High School, which was a 72% winning record. These wins included 14 sectional and regional championships.

Many of his players continued to play basketball at the college level at various colleges and university including: the University of Maryland, the University of Rhode Island, James Madison University, West Liberty College, Shepherd College, North Carolina College, Garrett Community College, Hagerstown Community College, Fairmont State College, Davis & Elkins College, and Glenville State College.

Bullett currently teaches Physical Education and serves as Head Varsity Boy's Basketball coach at Washington High School in Charles Town, West Virginia.

Bullett and his wife Traci Carter '83 reside in Kearneysville, West Virginia. They have one daughter, Dawn.

Dr. Leland Byrd

Dr. Leland Byrd, a native of Matoaka (Mercer County), coached the Pioneer Basketball Program from 1956 through 1966. At the time, his 118 wins were second only to that of legendary Coach Nate Rohrbough. His teams often beat perennial WVIAC powers Alderson Broaddus, West Virginia Tech, West Virginia Wesleyan, and Fairmont State.

Additionally, Byrd served as assistant football coach at GSC; including the year that Coach Nick Murin's 1958 team went undefeated in the West Virginia Intercollegiate Athletic Conference. He was also a former head of the GSC Physical Education Program.

"The time I spent here at Glenville State was some of the best years in my life. GSC President Harry Heflin '37 was the best administrator I ever worked for. I felt a great loss when I left the students, faculty, and community at Glenville," said Byrd.

At WVU, women's sports were elevated from club sports to varsity sports and the operating budgets doubled. The football team, under legendary Coach Bobby Bowden, participated in two bowl games and his decision to hire Basketball Coach Gale Catlett under a multi-year contract put the Mountaineers on a winning path.

One of Byrd's crowning achievements at WVU was planning, designing, and securing funding for Mountaineer Field, which was built shortly after he left WVU to become Executive Director of the Eastern Eight Basketball Conference and eventually Commissioner of the Atlantic 10.

In 1947, during his playing days at WVU, he was elected to the Helms

Foundation ALL America First Team and also named West Virginia's Amateur Athlete of the Year. For good reason, he became known as 'The Hammer' for his left-handed hook shot. The WVU teams Byrd played on regularly went to the NIT (the preeminent tournament at that time) and were ranked among the top teams in the country.

After graduation from WVU in 1948, he was drafted by the New York Knicks, but Uncle Sam came calling and he was drafted by the U.S. Army for a year. In 1950, he returned to WVU to study for his master's degree but was drafted again, serving as 1st Lt. Special Services at Red River Arsenal in Texarkana, Texas. It was there that he met and married Elizabeth Louise Machen in 1952


Byrd received all three degrees from WVU: Bachelor's (1948), Master's (1953), and Doctorate (1967).

Over the years, he has earned many honors including induction into the West Virginia Sportswriters Hall of Fame, the WVU Sports Hall of Fame, and the WVU School of Physical Education Hall of Fame. He was also named the WVU School of Physical Education's outstanding alumnus in 1996. Dr. Byrd was active on many NCAA boards and committees and was on the board of the U.S. Information Agency.

In 2010, the Department of Intercollegiate Athletics at WVU introduced the Leland Byrd Leadership Award which is presented to the top WVU men's and women's basketball players for leadership both on and off the court.

In addition to his professional career, Byrd was an Eagle Scout, President of the WVU Junior Class, and a member of Mountain honorary.

Leland and his wife Louise '59 split time at their homes in Morgantown, West Virginia and Fort Lauderdale, Florida. They have five daughters (Debbie, Becky, Cindy, Mary, and Nancy) and seven grandchildren.

Sandra Elmore, a native of Walton was the starting point guard as a freshman on the first Glenville State College women's basketball team in 1970. She is considered a trailblazer in getting women's intercollegiate basketball started at GSC and in the development of women's athletics in the State of West Virginia.

In 1973, Elmore graduated Cum Laude in just three years from GSC with a Bachelor of Arts Degree in Education with concentrations in Physical Education, English and Special Education.

"GSC was hard for me. I was challenged here by my professors. I had always heard that Glenville State had the best teacher education program and I believe that to be true today. I hope that I have made Glenville State College as proud of me as I am of being a Lady Pioneer," said Elmore.

She graduated Summa Cum Laude in both her master's and doctorate programs at West Virginia University. She also received advanced graduate study through Concordia University from Montreal, Canada and from the University of Physical Culture in Moscow, Russia. Elmore then completed post-doctoral studies at the Federal Institute of Physical Education and Sports of the Order of Lenin in Moscow, USSR.

Elmore was the first Head Women's Basketball Coach at Clay County Junior High School and at Ravenswood High School. She was the first Head Women's Basketball Coach at Potomac State College of WVU where she established a nationally ranked team over several seasons and had one undefeated regular season record at Potomac State. (72% over-all win/loss coaching record).

Elmore served as the first female Athletic Director at WVU Tech and was the first WVIAC female Athletic Director over the sport of football. She later served a second stint as Athletic Director at WVU Tech. She has also served as Head Women's Basketball Coach at WVU Tech.

While she was Athletic Director at WVU Tech, the football program achieved a Co-Conference championship in the WVIAC. The Men's Basketball program and the Women's Basketball program also won WVIAC Conference Championships. Elmore was inducted into the Potomac State College of WVU Athletic Hall of Fame in 1994, the West Virginia University College of Physical Activity and Sport Sciences Hall of Fame in 2006, and the Region XX National Junior College Athletic Association Athletic Director's Hall of Fame in 2000.

She was awarded the Women's Sports Pathfinder Award in 2003 by the National Association of Girls and Women's Sports, the highest National Honor Award in Women's Sports, and was awarded the Ray O. Duncan West Virginia Association of Health, Physical Education, Recreation, and Dance Award in 2003 for Service to the State of West Virginia in Physical Education. Additionally Potomac State's annual Female Athlete of the Year Award has been permanently named 'The Sandra J. Elmore Female Athlete of the Year Award.'

Elmore was primarily responsible for starting WVU Tech's Athletic Coaching Education program (2000) and the schools Sport Management program (2007). She currently is a Full Professor and Chair of the Department of Physical Education at WVU Tech. Under her leadership, the Physical Education Department had grown to the largest department on campus with a little over 200 students.

She currently resides in Nitro, West Virginia.



4 Dr. Stephen Taylor

Stephen Taylor, also a native of Walton, competed in football at GSC for four years and was a member of the 1958 WVIAC undefeated team.

He was a two-year starter on special teams and an offensive guard on the 1958 and 1959 teams. Taylor was selected as a tri-captain of the team his senior year.

Taylor graduated from GSC in 1960 with a Bachelor of Arts Degree in Education. He received a master's degree from Stetson University in 1969 and earned his Ph.D. from Florida State University in 1973. He also completed post-doctoral studies at Carnegie-Mellon University.

After six years in high school teaching, coaching, and administration, as well as two years with the Chrysler Corporation, Taylor entered the higher education field. He spent the next 23 years as a professor at Morehead State University (MSU) in Kentucky. Upon his retirement, he received the title of Professor Emeritus.

While at MSU, he chaired, directed, or co-chaired eleven university accreditation or reaffirmation committees. Dr. Taylor served with the National Council for The Accreditation of Teacher Education as well as the Southern Association of Colleges and Schools as a team member for the accreditation of other colleges and universities in four different states.

Dr. Taylor received the Kentucky Distinguished Educator award in 1987. He was appointed by two different governors to statewide committees on assessment and evaluation in secondary schools as well as college and universities.



Ed Tekieli, a native of Grant Town (Marion County), was a four-year letterman for the GSC Football Team and was the team's leading receiver for three years earning WVIAC ALL Conference honors for two consecutive years. He played offensive and defensive end, handled the punting duties, and was a team captain his senior year.

Ed was also a four-year starter on the Pioneer Baseball Team where he played center field for legendary Coach Carlos Ratliff '34. He excelled as a consistent defensive player and as one of the baseball team's leading hitters.

Additionally, Tekieli earned three letters in basketball and was one of the team's best rebounders and an aggressive defensive player. Due to a football injury, he was unable to play basketball in his senior year.

Tekieli earned a Bachelor of Arts Degree in Education from GSC in 1956. While at GSC, he served as Student Council President during his senior year and was a member of Kappa Sigma Kappa Fraternity, Alpha Delta Epsilon, and the G-Club. After graduating from GSC, he was the fifth recipient of the prestigious Frank Montrose award.

"Choosing to come to Glenville State was absolutely one of the best decisions I ever made. I had the great fortune to play for seven head coaches while I was here and each of them helped me form the foundation for my coaching career. I will always appreciate the educational and athletic opportunities that Glenville provided for me," said Tekieli.

In 1956, Tekieli was drafted into the Army where he played all three sports. Following basic training, he was stationed in Orleans, France where he played baseball and basketball and coached basketball. His team won the Com Z Championship in France.

He earned a Master's Degree in Physical Education from West Virginia University where he served as a graduate assistant for the Mountaineer Football Team. He received an Administrative Certificate from Kent State University and did additional coursework towards his doctorate.


Tekieli coached both high school and college football for 50 years. He was the Head Football Coach at Euclid High School where he also coached baseball and basketball. He was an assistant coach at Case Western Reserve University for two years. He coached football at Shaker Heights High School for 30 years. Although he retired from his coaching position at the school in 1998, he continued to coach as an assistant football coach for a number of years before retiring fully.

In 2007, he received the Greater Cleveland Football Coaches Golden Deeds Award and their Longevity Award. Additionally, he received the Ohio High School Football Coaches Association Assistant Coach Award in 1997 while he was coaching at Shaker High School. Tekieli served as the Honorary Coach for the Annual East West Football Game in 2007.

He met his wife, Delores while they were teaching at Euclid High School. They have three children: Ed Jr. and wife Ingrid; daughter Michele and husband Garret Ferrara; daughter Tiffany and husband Frank Phillips. Ed and his wife have seven grandchildren.

For more than 13 years, Ed has volunteered weekly at the Hospice of the Western Reserve. He is also a member of the American Legion and was a member of the Euclid Optimists Club.

The Tekielis love to travel and enjoy many activities with family, especially watching their grandchildren participate in sports. Coaching football has been his life-long passion and he still keeps in contact with many of his former players.

Waco on the rise Center



The Glenville State College Foundation is currently entering the final phase of fundraising for the Waco Center.

A portion of the center will house GSC's premier Land Resources Department. The center will also contain a medical center for direct access to quality health care for our students, faculty, staff and the surrounding community.

The Waco Center Arena, will provide not only a facility for the growth of the college's indoor sports, but also a location for the production of concerts, trade shows, and other events that can use a 3,000 plus seating capacity.

As important as bricks and mortar are to the college's future, the main focus of the Foundation remains scholarship support for an expanding student enrollment. With over 100 permanent scholarship funds under management, and 8 to 10 being added annually, the Foundation's stewardship of these funds is a lifeline to students at a time when the cost of attaining a college degree is increasing. Letters Home Reflect Difficulties of War

David, I am so glad that you are going into reserve, and you will be safe from the danger of battle for a little while, all of you needed the rest David watch the lines disappearing from under your eyes, you get lots of sleep. you will feel better now when you leave for home after the rest, much more relaxed David yesterday I wrote Mrs Chapman asking to let me know when she will come shopping again, and to come to tea. a to bring anyone she wanted to, I also told her just were going in reserve, David.

I saw Donald Wilson last night, next Saturday to see the Saddler, all over the morning, with J.B. Shady call Mr. David. How awful if you had been killed, what would I do, the children would be heart broken, and me David, I know one thing I would do, I would never risk them being married again, ever, the children, would need my David. Should God you are safe for us, I will soon be home to love us again David.

Veterans' Legacy Project

West Virginia Veterans' Legacy Project Director Dr. Bob Henry Baber recently received an unexpected gift during a visit to the West Virginia Veterans Nursing Facility in Clarksburg, West Virginia. He was at the facility to conduct interviews with veterans for the Glenville State College project. Dr. James B. Hill of Bridgeport, a staff physician, approached Baber and said he knew of a story that needed to be told.

Hill, a 26-year U.S. Marine veteran who served in the Vietnam War, did not want to be interviewed or share his experiences with the legacy project. Instead, he wanted to donate letters that his mother and father wrote to each other during World War II and the Korean War.

"There is an incredible story to be told through my parents' letters that spanned two wars. Their sacrifice and love for each other showed through. Mom did not know if dad would ever come home to us," said Hill.

David Hill of Harrison County, West Virginia, met and married Francis Erskine White while serving with the U.S. Army. Francis was British, and she had already lost her first husband Ted who was killed in World War II. Over the remainder of WWII and the Korean War, David and Francis (Frankie) Hill wrote hundreds of private letters to each other reflecting the hardships and sacrifice that the wars placed on their lives and the deep love that was undaunted by the circumstances.

So their son, Dr. James B. Hill, and the rest of the family have donated hundreds of those letters to the West Virginia Veterans' Legacy Project so that the love story of David and Frankie could be told.

Some of David's letters home were written on the back of letters that he received. At least one letter was written on the back of a map. Another letter has a terrain sketch of the battle field and his account of the battle.

In the fall of 1951, David Hill was counting down the days until he returned from Korea.

The following passages are from the letters that were sent between David and Frankie:

From: David Hill
Korea - October 23, 1951

Dearest Frankie, Today is a beautiful day. I love you. It is 28 days until I leave. I wrote a letter last night to Uncle Jim Burris telling him the news and that you and the children are well.

I can hardly realize that in four weeks I will be on my way to see you and my children again. After the disappointment last August, I went through several very bitter days until I decided to make the best of it...

From: Francis Hill
October 25, 1951

Dearest David, I am so glad that you are going into the Reserve. Now, you will be safe from the danger of battle for a little while...


Dr. James Hill reads from correspondence that his mother and father wrote to one another during World War II and the Korean War.



“We are so fortunate that these letters just fell into our laps. These letters are profoundly intimate and deliver a powerful and graphic exchange about the horrors and sacrifices of war that service men and women and their families must endure. We are thankful to the Hill family for sharing the story that they tell now and for generations to come,” said Baber.

The Hill letters are being included in all of the products of the West Virginia Veterans’ Legacy Project. They are featured in a traveling photo show, some have been printed in the project’s first book *Heroes Among Us*, and others will be read as part of a multimedia event about Mountain State veterans entitled ‘Morning Stars, A Tradition of Service.’



“This program is a gift to me. I am honored to help guide this project and keep the stories of our service men and women alive for years to come. All veterans are encouraged to submit their stories about their time in the military. Memorabilia, letters, articles, and photographs are also needed to be digitally saved and help make this project a bigger success,” said Baber. The stories and memorabilia of deceased family members may also be contributed.

GSC Library Associate Jason Gum '05, who oversees the GSC archives, is assisting Baber with the project. “Veterans’ experiences are part of the American being. A West Virginian’s story of service complements a collective identity that West Virginians can share. The Legacy Project will engage students in realizing cross-generational traditions, values, and norms that characterize the era and the region. Students working with the project will be introduced to a vital segment of West Virginia history, interact with historians, and develop research skills,” said Gum.

Baber says this project will be a celebration of veterans of all ages and genders. ■

‘A Tradition of Service’ Photography Exhibit Chronicles Vets Lives

Glennville State College’s West Virginia Veterans’ Legacy Project’s first product, a stunning thirty-six-piece photography exhibit, ‘A Tradition of Service,’ will soon be on display in GSC’s Fine Arts Center Gallery. It is currently being moved from its initial debut site at Yeager Airport in

Charleston, West Virginia.

The show primarily features photos of living veterans from World War II and through subsequent conflicts up until the present. The photos were taken by award-winning professional photographer Mark Romano, a 1992 GSC



graduate. Veterans from the West Virginia Veteran's Nursing Facility in Clarksburg, the VA Hospital in Beckley, and numerous other regions of the state are featured in the show.

"It's hard to contain our excitement about this show. It's exciting on so many levels. It's the first tangible product of over 200 veteran interviews conducted over the past two years. And, of course, we were pleased to again partner with Yeager Airport in highlighting West Virginians' long tradition of giving above and beyond the call of duty in so many ways," said Dr. Bob Henry

The project has been made possible through funding provided by the U.S. Institute of Museum as well as contributions from many other organizations and individuals. In order to maximize the Legacy Project, GSC seeks additional support from any and all entities wishing to highlight the fact that West Virginia has had, and continues to have, the highest per capita service rate in the United States.

The show will reopen at Glenville

State College on Monday, November 5 at 5:00 p.m. when it will open along with the publication of the project's first book, *Heroes Among Us*, a collection of photographs, both new and old, with succinct vet quotes and short stories.

After the exhibit closes at GSC, it will be available to museums, art galleries, colleges, and all other appropriate venues for free. Additionally, an installation piece for smaller spaces such as business lobbies, city halls, veteran meeting places, and festivals will be available. ■

Improving K-12 Curriculum Goal of HPC, JASON Project

An important facet of Glenville State College's Hidden Promise Consortium is the partnership with the JASON Project. GSC partnered with the JASON Project to enhance the efforts of the Hidden Promise Consortium goal of unlocking the 'hidden promise' of K-12 students in the participating counties. The partnership strives to create highly qualified teachers by increasing their knowledge of science and preparing them to inspire and motivate their students through use of the JASON Curriculum. The goals of the program blend seamlessly with those of the GSC Hidden Promise Consortium," said John J. Gersuk, Vice President, External Relations, JASON Project.

JASON's curriculum, designed for students in grades five through eight and used throughout K-12 for differentiated instruction, reaches an estimated two million students annually. All units are aligned to state and national science standards and have garnered multiple national education and technology awards.

More than 11 million students and teachers have used JASON curriculum since its founding in 1989.

Since the summer of 2009, approximately one-hundred and ninety-six teachers from twenty-three counties in West Virginia have learned the JASON curriculum at teacher workshops at Glenville State College. These JASON trained teachers have incorporated the JASON curriculum into their classrooms bringing the excitement of the world of science to over six-thousand students.


