 - i. Vice-President Barber mentioned that the Mic Night turned out really good. He also mentioned that the eSports Arena should be finished soon.

- X. Old Business:
 - i. SGA Website/Email:
 - i. President Tarman reminded everyone that we mentioned items to add to the SGA website and to email items to send out to the student body.
 - ii. Meet and Confers:
 - i. President Tarman reiterated that the Meet and Confer is coming up. It will be held shortly after the SGA meeting and open to all students.
 - iii. Library Mural Project
 - i. President Tarman reminded the group to be thinking of books to include on the library mural since it will be starting up soon.
- XI. New Business:
 - i. Secretary Position:
 - i. President Tarman restated that this position is still open. If you're interested, please let one of the Board members know.
 - ii. Spring Academic Calendar Update:
 - i. President Tarman mentioned that Dr. Morris sent his recommendations for the Spring Calendar to the College Leadership Council. It was mentioned in the

group that we should try to incorporate a one-day, midweek break somewhere throughout the semester. Individuals stated that we are all typically exhausted come the end of the semester if we have no days to catch up on things. This midweek break would hopefully cut down on the amount of travel we would have among the students.

- i. Senator Barger stated that she still thinks people would leave for multiple days if that were to happen. She also mentioned that we could have several events going on throughout the day to ensure that students stay.
 - ii. It was restated that there's nothing stopping anyone from going home or traveling.
 - a. President Tarman mentioned that the hopes would be that students would realize that they still have class on that Thursday or Friday and not leave.
 - b. Senator Miller brought up the idea that some professors usually don't give assignments or have class the Friday of the week if there is a midday off throughout the week.
 - i. President Tarman stated that this problem would be something that Dr. Morris would need to address.
 - ii. Advisor Keene mentioned that this would be a high possibility since there is more leeway this year.
 - c. Vice-President Barber asked why we wouldn't do a Tuesday instead.
 - i. President Tarman mentioned that the idea was to have two separate days throughout the semester. One day would be a Wednesday and one would be a Tuesday.
