Ms. McClain provided information regarding what can and cannot be done to buildings once they are placed on the Registry. The only thing that may not be changed is the original aesthetics of the structure; however, any renovations done need to match the original as best as possible. Ms. McClain viewed the buildings on campus from various points in downtown Glenville and noted that all would qualify to be placed on the state Registry with the exception of the Fine Arts Center and Goodwin Hall because both are not old enough. Conner and David Hutchison will be meeting with Doug Patterson this week to discuss the grant and bids for Alumni Center renovations.

Explore Single Structure verses District and How to Proceed

Jason Gum announced that Tisha Underwood researched the single structure verses the district and found a lot of information. After review of the information, it was recommended to pursue a GSC Historical District.
