Clarification of Certificate vs. Micro-Credential:

- Mari addressed the committee about the differences between certificates and micro credentials:
 - HEPC has not determined what the criteria for micro-credentials will be
 - Students will be able to take classes towards a micro-credential even if they are in a similar major
 - It is hard for students to complete minors along with their degree as well. Only two majors require a minor at this time (English & Chemistry)
 - Micro-credentials can also be used to recruit non-traditional students

- A.S. Criminal Justice
 - Removed PED 201 & 301, replaced with 1 hour of general elective
 - o David motioned to approve, Sara seconded. Motion passed

 Due to the amount of curricular changes needing to be discussed, this topic was pushed to a later meeting

Nonprofit Certificate Clarification

- The original memo did not state the Nonprofit Leadership & Management Minor would be discontinued
- The course outline for MGMT 301 was revised to add "or permission from instructor" to the prerequisite line

- The prerequisites need to be reordered
- The committee made the decision to remove MGMT 201 from the requirements of the certificate, which would make the certificate 12 hours
- Schuyler motioned to approve adding "or permission from instructor" to prerequisite line on the course outline for MGMT 301, for the prerequisite of MGMT 201

CSCI 280

- This is a new course replacing what has been taught in CSCI 399 this year
- Schuyler motioned to approve the new course, Kaitlin seconded. Motion passed

New Business

MGMT 383 Discontinuation

- Management Major:
 - o Removed MGMT 383
 - o Removed FINC 421, MGMT 402 from requirements
 - Reordered restricted electives
 - o Cheryl motioned to approve, Kaitlin seconded. Motion passed
- Management Minor:
 - o Removed MGMT 383, which makes the minor a total of 15 credits
 - o Kaitlin motioned to approve, Cheryl seconded. Motion passed
- Sports Management Major:
 - Removed MGMT 383, replaced hours with 3 hours of general electives at the 300-499 level
 - It was brought up during the meeting that students are often misadvised with this major due to the number of general electives needing to be at the 300-499 level, so that students graduate with the required 39 hours of upper-level hours
 - Schuyler motioned to approve, David seconded. Motion passed
- Art Major:
 - Removed MGMT 383 from the list of restricted electives and Strategic Design career pathway
 - Removed BIIOL 309 from the list of restricted electives and replaced with HLTH 230
 - The plan of study was revised to re-order ART 201, 202 and 270 to place them in the correct sequence
 - David motioned to approve, Schuyler seconded. Motion passed
- Energy & Land Management Major:
 - Removed MGMT 383 from the list of General Block Electives
 - o David motioned to approve, Kaitlin seconded. Motion passed
- Social Justice Minor Certificate
 - Due to MGMT 383 being discontinued, the Social Science Department decided to discontinue the Social Justice Minor, and replace it with a Social Justice Micro-Credential
 - o The learning objectives for SOCS 230 & POSC 309 were revised
 - Schuyler motioned to approve, Donal seconded. Motion passed

RBA

- HEPC changed the amount of years students have to wait to enter the RBA program after high school to 3 years, instead of 4
- The Criminal Justice Area of Emphasis was updated, and cut from 18 hours to 15
- Tim motioned to approve, Schuyler seconded. Motion passed
