- I. Vice President Maddy Lynch called the meeting to order at 12:36 p.m.
- II. Public Comment:
 - a. Zoey Steele announced a First-Generation Stem Club that would support STEM, low-income, and rural children. There are two scholarships available for anyone who wants to participate.
- III. Attendance:
 - a. Parliamentarian Mullins took attendance.

- V. President Report:
 - Sydney Beckett was designated by President Wade as the Social Science Representative. It was moved by Representative Gibson and seconded by Senator Menjor.
 - b. "The Roaring 20's" is the theme of the Founder's Day Formal, which is scheduled for February 15 from eight to ten o'clock.
 - c. Tori Cutwright withdrew from the Student Government Association, and the representatives at the current meeting will select the speaker of the house.

- b. Treasurer: Announced Finance Committee to be advised for a meeting soon.
- c. Secretary: declared that she would compile a list of all the committees and their members.

- a. Representative Gibson: provided the Government with an update on the Academic Policy, indicating that the regulations for multi-semester registration had been revised to bullet points and had been accepted. - c. Senator Hypes: stated the food services will have a more obvious allergen labelling within the following week. In addition, the debate team will go to Dayton, Ohio on February 9 and 10, and in March there will be a debate on campus.
- d. Senator Rowse: declared that the Environmental Club will be meeting with the Board of Governors, so please attend.
- e. Representative Osborne: stated that Senator Hypes of SGA had been appointed to the role of President of the Criminal Justice Honor Society. And Brandon Davis was appointed Vice President.
- f. Representative Jones: mentioned that a music convention, featuring a brass assembly, is taking place in the Fine Arts Building
- g. Representative Sherman: announced that the SCA for Christian athletes and fellowship will meet next Tuesday.
