VIII. Executive Reports

- a. Vice President: She stated the issues on campus are being looked into.
- b. Treasurer: She discussed going over the books for her position with President Breanna Morgan. Also, stated wanting to go over a few things with Representative Gibson for different situations in Goodwin. She talked about working with the LGBT+, having new ideas for them (ex. Speakers.) Mentioned sanction event ideas one day a week that are SGA related.
- c. Secretary: They stated a LGBT+ Meeting Monday, January 30th. Also stated about this past meeting on Tuesday, January 24th about the organizations and them needing more recognition.
