- VII. President's Report:
  - a. President Wade informed the assembly:
    - i. All the things for Homecoming have been approved except for the Pickens events, which Liaison Ferguson just has to get approved.
    - ii. Naomi Sanders is inviting SGA to be involved in a potential "Trick or Treat" that the other Orgs on campus are doing.
    - iii. Senator Menjor is coming up with the petition for the Dog Waste Stations and Treasurer Hawkins will explain more on the financial aspect of the stations.

## VIII. Executive Reports:

a. Vice President: Informed everyone that Events committee is meeting tomorrow. Hopefully, they will get every detail figured out for Homecoming and Liaison Ferguson can have it approved.

- b. Treasurer: Finance committee is waiting on budget requests for Homecoming or for someone to bring up the T-shirt budget again. The stations are about \$200 a piece, we will need 4-6 of them to fit the needs of the campus. It would be \$800-\$1200 (10%-15%) of the budget.

### IX. Committee Reports:

- a. Co-Curricular Committee: Majority Leader Hypes informed the assembly that the committee is currently reviewing alternating courses, ones that happen on odd number of years and specific seasons, to see if they need to add more of them because students and teachers have been having special sessions which costs a lot more for the school.
- b. Facilities Committee: Representative Taylor informed the assembly that he and Speaker Floyd met with the committee on Monday and discussed further steps and actions to solve the transportation issues. They concluded that they are going to do a survey for students to prioritize what issues are more important.
- c. Academic Assessment: Representative Noah Jones informed the assembly that he met with the committee on Tuesday, only three of the departments have turned all of their statistics from last year (2023-2024). The three departments are Health and Science, Music, and Visual Arts. The committee urges other departments to get their statistical assessments in as soon as possible. The Music department has to do some revisions, and the Visual department has to do major revisions.

#### X. Assembly Reports:

- a. Speaker of House/ Social Science Rep Floyd: None. (Majority Leader Hypes gave Speaker Floyd's report).
- b. President Pro-Temp/ Math and Science Rep Gauldin: Informed the assembly that SAAC met last night, and that Vice President Howe informed them that SGA needs at least one SAAC representative.
  - i. Shared the goals for SAAC. One is to get people's attendance from across boards, and across campus, all sports are going to be at certain events that are at home. The first one is going to be the Football Homecoming which

- is Saturday, October 12, 2024. Potentially the soccer game vs Charleston on Wednesday, October 30, 2024. Wrestling Invitational that is being held Saturday, November 2, 2024. The volleyball game vs Charleston is on Saturday, November 12, 2024. Men's and Women's basketball game on Saturday, November 16, 2024. At least one game for each sport so please try to be there if you can.
- ii. Also, for any student athletes, the first and third of every month will be Mental Health Awareness days. If there are any questions, please email Coach Perkins.
- iii. There is also a meeting next Wednesday to vote on some new NCAA rules and if any of those come into effect then he will inform the assembly.
- c. Criminal Justice Representative Kohlphenson: Informed the assembly that she should get to meet with the department head, Monday of next week.
- d. Education Representative Crites: Informed the assembly that she is meeting with the head of her department tomorrow. Also, shared an update of Clark Hall's situation in the basement, stating it did not flood and they do think that they know the problem, but it has not been confirmed yet.
  - i. Followed up on the issue about one of the Education majors getting hit by Public Safety on the hill. She says that a mirror should be placed there and wants to send the issue to a committee.
