- II. Attendance was collected by Parliamentarian Tanner and Quorum was met
- III. Amendment to the Agenda:

    - i. Representative Bennett motioned for the resignation.
    - ii. Representative Gibson seconded the resignation.
    - iii. The Assembly unanimously approved the resignation of Senator Charles Copeland.
  - ii. Swearing in New Members
    - i. Senator Alfred "Fredo" Menjor appointment
      - i. Representative McDermott motioned for the appointment.
      - ii. Representative Devins seconded for the appointment.
      - iii. The Assembly unanimously approved the appointment of Alfred "Fredo" Menjor as a Senator.
    - ii. Justice Charles Copeland
      - i. Representative Bennett motioned for the appointment.
      - ii. Representative Cutright seconded the appointment.
        - Representative Lynch inquired about which group appointed Charles Copeland as Justice. The recommended

- appointment was not disagreeable; however, wanted clarification from the executive cabinet.

    - i. Senator Hypes motioned for approval for Demos.
    - ii. Representative Devins seconded approval for Demos.
    - iii. The Assembly unanimously approved Demos to be an organization for Glenville State University.
- XI. Advisor & Administrative Liaison Updates/Comments
  - i. Liaison Ferguson congratulated all the newly elected Assembly Leadership position holders on taking the next big step in SGA.
