



**Articulation Agreement
Between Northeast College of Health Sciences &
Glennville State University**

This Agreement is made this 12th day of January, 2025 between Northeast College of Health Sciences, a private institution of higher education located at 2360 State Route 89, Seneca Falls, New York 13148 (hereinafter Northeast) and Glennville State University located at 200 High Street, Glennville, WV 26351 (each a "Party" and collectively the "Parties").

In the spirit of mutual interest in cooperation, Northeast and Glennville State University enter into this Agreement for program articulation and collaboration and agree as follows:

ARTICLE 1: PARTNERSHIP PURPOSE

Based on a mutual respect for the integrity of parallel academic programs and in an effort to better serve students intending to pursue the profession of chiropractic at Northeast, Glennville State University and Northeast hereby enter into an Agreement. This Agreement outlines the scope of collaboration and appropriate course work to be completed at Glennville State University, or equivalent transcribed courses completed by students intending to complete an undergraduate degree, and also fulfill requirements for admissions to the Doctor of Chiropractic degree program at Northeast.

ARTICLE 2: OBJECTIVES OF THE AGREEMENT

1. To attract qualified students to Glennville State University and to Northeast.
2. To encourage academic and administrative collaboration between the two institutions for the benefit of students.
3. To facilitate an efficient transition of qualified students from Glennville State University to Northeast.
4. To provide appropriate advisement for students pursuing the articulated program by faculty and staff members of both colleges.

ARTICLE 3: SCOPE OF PARTNERSHIP

3.1 Areas of collaboration may be proposed by either institution and may include, but are not limited to:

- 4+3 articulated degree programs

3.2 All activities shall be subject to the approval of each institution's authorized representatives.

3.3 Each activity is to be included as an Addendum to this Agreement.

ARTICLE 4: FERPA

The parties acknowledge that information (if any) provided to, and/or received from, Northeast regarding students may be protected by the Family Educational Rights and Privacy Act ("FERPA"), and agree to use such information only for the purpose for which it was disclosed, and not to make it available to any third party without first obtaining the student's written consent, except to the extent disclosure without such consent is permitted by FERPA.

ARTICLE 5: USE OF LOGO AND NAME TO PROMOTE THE PROGRAM

Each Party grants, for the term of this Agreement, a limited, non-exclusive, royalty-free license to use its logo, trademarks(s), service mark(s) and (collectively the "trademarks"), to the other Party, solely for the promotion of this Agreement and any Programs developed hereunder in its brochures and other public information materials having to do with Program(s). Each Party agrees that each time it reproduces and/or republishes the other Party's Trademarks it shall do so in a form identical to that provided by each Party, without alteration and in accordance with any use guidelines provided by the other Party. Each Party agrees to use the other Party's Trademarks in a careful and prudent manner. Except as otherwise set forth in this paragraph, each Party agrees not to use the other Party's Trademarks or other intellectual property in any manner whatsoever without prior written consent in each instance. Requests pertaining to Northeast shall be made to the Assistant Vice President of Enrollment Development and Admissions. Request pertaining to Glenville State University shall be made to the Director of Marketing and University Relations. The Parties acknowledge by this Agreement, that they acquire no right, title or interest in and to the other Party's Trademarks whatsoever other than to use the Trademarks in accordance with the terms and conditions hereof. The use of each Party's Trademarks may not be assigned, transferred, shared, or divided in any

manner by the other Party without prior written consent in each instance, and any such purported action without consent shall be void.

ARTICLE 6: COMMUNICATIONS & NOTICES

Each Party shall send communications or notices pertaining to this Agreement to the other Party at the relevant address set forth below or to such other address designated by that other Party through written notice.

ARTICLE 7: DURATION AND EVALUATION

7.1 This Agreement shall be in effect for a period of 3 years from the last date of signature.

7.2 Either party may terminate this Agreement upon notice, in writing, given to the other Party ninety (90) days prior to the effective date.

7.3 Either Party may terminate this Agreement upon thirty (30) days' prior written notice of a material breach by the other party, unless the breaching Party cures the breach to the reasonable satisfaction of the non-breaching Party within such thirty (30) day period.

7.4 Either Party may terminate this Agreement on ten (10) days' prior written notice in the event that the other Party engages in conduct which is unethical, unlawful, or adverse to the reputation of the terminating Party; provided, however,

that such notice must state with sufficient detail the particular conduct giving rise to the notice of termination and the basis for attributing such conduct to the terminating Party.

7.5 Either party may terminate this Agreement immediately upon notice to the other party in the event that any court, governmental authority or accreditor of competent jurisdiction determines that the terminating Party may not participate in this Agreement or in agreements of this nature.

7.6 Except to the extent (i) required by law or applicable accreditation requirements, or (ii) necessary to ensure the safety and wellbeing of participating students, termination of this Agreement shall not affect students already accepted for participation in the Programs, who shall be allowed to complete the Programs per terms outlined in this Agreement.

7.7 Amendments to this Agreement may be requested, in writing, by either Party and are subject to written approval by the authorized signatories. Any Programs in progress at the time of any amendment shall be permitted to conclude as planned unless otherwise agreed in writing.

ARTICLE 8: DISPUTE RESOLUTION

In the event of a dispute arising out of or relating to this Agreement, the Parties commit to using good faith efforts to find a resolution.

ARTICLE 9: NON-DISCRIMINATION

9.1 The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, sex, age, handicap, political affiliation, sexual orientation, disability or status as a veteran.

9.2 In performing their respective activities contemplated by this Agreement, each Party shall comply with all the applicable national, state, and local laws, codes, ordinances, rules and regulations.

ARTICLE 10: MISCELLANEOUS

10.1 The parties shall be independent contractors and not partners, joint venturers, principal and agent, or parties to any other similar legal relationship. Neither Party

shall have, or hold itself out as having, the power or authority to bind or create liability for the other party by its negligent or intentional act or omission.

10.2 This Agreement is not intended to benefit any third party, nor shall any person or entity who is not a Party hereto be entitled to enforce any of the rights or obligations of a Party under this Agreement.



APPENDIX A: 4 + 3 ARTICULATION AGREEMENT

1. Under this advisement sequence, students will matriculate at Glenville State University in a program of study leading to a baccalaureate degree in **Health Sciences Pre-Chiropractic Concentration, or any Program of Emphasis (POE)** and includes course work required to satisfy all entrance requirements of Northeast. That program (sequence suggested) includes the following:

STUDENT LETTER OF INTENT TO ATTEND NORTHEAST (*attached*)

2. Students may acquire a portion of the required coursework necessary to satisfy all entrance requirements of Northeast. Up to 20 semester hours of a candidate's pre-professional requirements can be earned through the College Level Examination Program (CLEP) and certain other college proficiency examinations. These credits must be granted by an accredited, degree-granting institution (NOTE: science prerequisites cannot be satisfied through examination programs).
3. Students must complete the course of study at Glenville State University with a cumulative Grade Point Average of at least 3.0 (see note below) and earn a minimum of "C" (2.00) in all specified courses.
4. Students entering with a 3.0–3.499 cumulative Grade Point Average from Glenville State University will be automatically awarded a Northeast merit scholarship valued at \$ 2,000.00. Students entering with a 3.5 or higher cumulative Grade Point Average from Glenville State University will be automatically awarded a Northeast merit scholarship valued at \$3,000.00. These scholarships are non-renewable and dispersed equally between the first and second Northeast trimesters only.
5. Within their first two years at Glenville State University, students will submit their intent to Northeast Admissions, 2360 State Route 89, Seneca Falls, NY, 13148 identifying themselves as articulation students and their desired date of entrance to Northeast. The Letter of Intent must be signed by the student's advisor, signaling realistic and accurate desired Northeast entrance date (SEE APPENDIX).

6. Students must apply for admission to Northeast one year in advance of their desired entrance date and complete all Northeast application requirements.

In recognition of student completion of the program, including procedures outlined above, Northeast shall accept students who have fulfilled the requirements set forth herein, and all generally applicable Northeast admission requirements, for the entrance date of their choice.

NOTE: Students who do not maintain a cumulative GPA of at least 3.0 from Glenville State University but complete the program with a GPA of 2.75 or better, will receive appropriate special consideration for admission to Northeast, acknowledging the completion of the Articulation sequence at Glenville State University.

7. Glenville State University and Northeast both agree to freely and widely encourage qualified students to participate in this program by providing advisement, information, and other such assistance to ease transition of students to chiropractic study. Diligent efforts will be made by appropriate personnel at Glenville State University to maintain an accurate listing of articulated students pursuing the Doctor of Chiropractic program at Northeast. In turn, appropriate personnel of Northeast shall promote the Articulation Program of Glenville State University and refer interested students to the College's admissions office where appropriate.

8. Both institutions hereby agree to notify the other in the event of substantive changes in courses, programs or policies that have an impact upon any aspect of this Program. Adoption of entrance standards by Northeast that are inconsistent with the terms of this Articulation Agreement would require revision or termination of the Agreement.
