- o Reports
  - Mary Alltop
    - ACCE- Senate Bill 480 is very important as it is written (time of meeting) because it gives us FACTS (Fair – Accountability – Credibility – Transparent – Systematic) At the time of ACCE meeting it has passed the Senate and in the House now – Poling had some amendments
    - Items of interest discussed by the new Vice Chancellor Walthers
      - There are concerns about the State Office of Technology consuming WVNET. This would move WVNET from its current location in Morgantown to Charleston.
      - Consider training of supervisors for performance reviews. Classified staff should be evaluated annually and if not then should ask supervisor for evaluation.
      - Legislators say institutions have money for salary increases, but institutions say they don't.
      - When ACCE (and Staff Council) have a problem or issue. When that issue is brought forward, solution options should be presented at the same time.
    - Issues-The LBH elevator is now locked to the second floor at all times. There was no campus notification that this was going to happen. It brings up questions of ADA accessibility to IT, Academic Support, and the 3<sup>rd</sup> floor classroom.

    - It has been determined that not all of the positions on this list have PIQs.
    - In the opinion of some council members, these positions should have been hired as classified positions in the beginning.
    - Staff Council would like to have a PIQ for every classified position on campus updated.
  - Classified Staff Council is to make the annual presentation to the GSC Board of Governors at their next meeting. Council members should notify Jason Phares or Mary Alltop before April 1, 2010 to add anything to that presentation. SB 480 is to be included in that presentation.
