Ann Reed asked how much the budget cut was going to be? Dr. Barr said 8.9% budget cuts across the board. She then asked how this would affect us? Dr. Barr said that at the last Board of Governors meeting they approved a 8.9% Tuition and Fee increase so it will be almost a wash.

Mary Alltop asked Dr. Barr to welcome people to the Advisory Council meeting being held on our campus May 1<sup>st</sup>.

Jim Tatman asked if the hiring freeze affected us? Dr. Barr said no but the institution is looking close at positions. Jim said they are really short handed in Maintenance and the employees are really concerned about this. Dr. Barr said he would talk to Tommy about these positions.

Jim called meeting to order at 8:30 a.m.
