- This could be expensive to the college and burdensome for those faculty who are conducting the search.

#### **Larry Baker (Vice President Reports):**

• Larry states the Staff Council has approved the Faculty Senate's survey for tuition waivers. Lois Miller made the motion for Faculty Senate to run a survey to include classified

- staff concerning the tuition waiver policy. Ann Reed seconded the motion. Motion passed unanimously.
- It is believed that all surrounding colleges already have tuition waivers that have no restrictions. The only college that has restrictions is Shepherd University.
- It is believed the waivers are important when retaining staff employees.
- The Staff Council has voted for the Faculty Senate to proceed with the survey and do so in a swift manner. They are concerned of running out of time before hiring new employees and therefore loosing potential strong candidates.

#### III. UNFINISHED BUSINESS

#### **Tuition Waiver Survey**

- Baker distributed a draft of the tuition waiver survey. O'Dell asked for comments/suggestions from the Senate.
- Perkins asks if a question should be included whether the dependent would be degree seeking or non-degree seeking and how many hours would they attend?
- Batson asks whether summer classes can be taken.
- Baker responds by saying employees and staff can but waivers will be limited for spouses and dependents.
- Mills asks what happens when someone gets lower than a 2.0 GPA?
- Perkins asks whether question #5 could be a YES or NO question?
- Peek states he's leery of YES or NO questions. #10 and #11 could include strongly agree, agree and so on.
- Morris states # 7 could also be YES and NO.
- Evans states #5 could be divided into two questions. Add a question before #5: How many dependents do you have under 25 and how many plan on attending school?
- Baker states there will be no extra cost to the college. The college will actually collect funds on fees, such as parking that is not covered in the waivers.
- Motion to send out Survey to the college with suggested changes. Wemm/Morris m/s

- Senate voted and then passed votes to Gary Morris.
