The Glenville State College Foundation, Inc is a private, non-profit tax-exempt [501(c)(3)] corporation which was founded to acquire and manage a wide range of funds that are used for scholarships, awards, and special projects for the College. Overseen by an active and dedicated Board of Directors, the Foundation was established to:

- Provide funds for scholarships, endowments, educational research, improvements and additions to school facilities and general educational purposes for Glenville State College and for the students at Glenville State College;
- Engage in and promote educational, literary, scientific, charitable, philanthropic, fraternal and benevolent activities;
- Receive and use for its purposes, gifts, donations, bequests, and endowments;
- Establish, maintain, manage, handle and administer trust funds for scholarships, endowments, educational research, and other educational, literary, scientific, charitable, philanthropic, fraternal and benevolent purposes;
- Acquire, own, hold, lease and sell property, real and personal, in connection with its purposes.

Mr. David Helmick serves as Interim Director of the Foundation. The Foundation office is located in the Administration Building.

The 2005-2006 Annual Fund raised \$101,000 of support for the College. Sixty-five percent of those funds were received from alumni and friends, thirty percent from business and industry, and five percent from faculty and staff. Fourteen percent of faculty and staff participated in giving to the Annual Fund. Fund disbursements were as follows:
